

Amendment to the Call for applications for admissions to the Bachelor's Degree programme in Architettura-Architecture - academic year 2019/20

Rector's decree no. 639 of 18th June 2019

THE RECTOR

- Having regard to the University Statute;
- Having regard to the current General Academic Regulations of the University;
- Having regard to Ministerial decree no. 277 of 28th March 2019 concerning "Methods and contents for admission tests to single-cycle Bachelor's and Master's degree programmes with nationally programmed admissions for a.y. 2019/2020" and its annexes;
- Having regard to Rector's decree no. 628 of 17th June 2019 concerning the "Call for applications for admissions to the Bachelor's degree programme in Architettura-Architecture – a. y. 2019/2010" (hereinafter referred to as the "Architecture Call") and its annexes;
- Having regard to Ministerial decree no. 470 of 13th June 2019 introducing "Amendments to the deadlines referred to Annex 1 and 2 of the decree of the Ministry of Education, University and Research of 28th March 2019, protocol no. 277" concerning "Methods and contents for admission tests to single-cycle Bachelor's and Master's degree programmes with nationally programmed admissions for a.y. 2019/2020";
- Considering that the above-mentioned decree modified the registration deadlines for the admission test for the Bachelor's degree programme in Architettura- Architecture referred to in article 5 of Ministerial decree no. 277/2019 and also changed the deadlines by which applicants are required to list the universities they are going to compete for;
- Having received the information about the amendments to the above-mentioned deadlines on 18th June 2019 with Ministerial note no. 20693 of 18th June 2019 sent by the *Dipartimento per la formazione superiore e per la ricerca - Direzione generale per lo studente, lo sviluppo e l'internazionalizzazione della formazione superiore - Ufficio 3° - Accesso programmato e formazione superiore ai fini dell'insegnamento scolastico*;
- Considering that article 3, paragraph 1 and 3 of the Architecture Call reports the deadlines listed in Annex 1 and 2 of Ministerial decree no. 277/2019;
- Having understood that it is necessary to modify article 3, paragraph 1 and 3 of the Architecture Call;

DECREES

1. that Politecnico di Torino should change the deadlines by which applicants must register for the admission test for the Bachelor's degree programme in Architecture-Architettura (art. 3, paragraph 1 of Rector's decree no. 628/2019):

Applicants are required to register for the admission test online only and they must complete the following steps:

- a) applications from the www.universitaly.it portal starting **from Wednesday 03th July 2019 until Thursday 25th July 2019 at 3:00 p.m. (GMT+2)**.
- b) online registrations on the Apply@polito platform (available on the website of Politecnico di Torino) for the choice of the Bachelor's degree programme and the payment of the test registration fee. Payment must be completed by **Tuesday 30th July 2019**.

2. that Politecnico di Torino should change the deadlines by which applicants must choose the universities they want to compete for and rank them in order of preference (art. 3, paragraph 3 of Rector's decree no. 628/2019)

- Upon registration for the admission test, applicants must rank the universities they intend to compete for in order of preference. These preferences **are irrevocable and cannot be modified or added after 3.00 p.m. (GMT +2) of 25th July 2019**. The last "confirmation" given by applicants before the deadline is considered as the final and sole choice.
