



## TOPoliTO Scholarships – Master of Science programs Selection for international students enrolling in the 2022/23 academic year

### Provisional lists of standings

This lists of standings is based on the requirements and deadlines established by the TOPoliTO Scholarships – Master of Science programs [announcement of selection](#) for international students enrolling in the 2022/23 academic year.

The list of standings is to be considered **provisional**. It has been drawn up according to awarding requirements and procedures defined in art. 2, 3 and 4 of the announcements of selection. It includes students who **have been admitted to a Master of Science program for a.y. 2022/23**, have applied for TOPoliTO scholarships and are **eligible but subject to verification** or **not eligible** for the scholarship.

<b>13/09/2022</b>	deadline for the <b>acceptance</b> of the scholarships by <b>scholarship recipient subject to verification</b>
<b>20/09/2022</b>	publication of <b>updated final list of standings</b> upon reassignment in case of withdrawal of scholarship recipients.

TOPoliTO scholarship recipients are all to be considered as "**subject to verification**" until Politecnico completes the verification process of the requirements and incompatibilities, according to art. 2 of TOPoliTO [announcement of selection](#), not later than June 30th, 2023. Without prejudice to further verification on the conditions for maintaining the scholarship pursuant to art. 8 of the [announcement of selection](#).

If the verification process reveals that a student does not meet one or more TOPoliTO requirements of [announcement of selection](#), his/her scholarship assignment will be revoked with immediate effect and possible retroactivity.
