

## Statement for Alta Scuola Politecnica Enrolment

I undersigned, ID number, having presented
my candidature to be enrolled in the Alta Scuola Politecnica for the academic year 2023/2024 (XX cycle), declare that I am aware that:
<ul> <li>The ASP programme is additional to the regular Master Degree programme and as such require an extra effort.</li> <li>The ASP courses are compulsory, therefore they can be missed only in exceptional cases, e.g. health problems or overlapping compulsory activities of the Master Degree programme; these exceptions are regulated in detail by the student guidelines, which will be available on the ASI website. In this respect, internships and thesis work are in general not considered as overlapping activities, since they can be planned in order not to conflict with ASP courses.</li> <li>While talented students may have several opportunities for additional technical and personal development within their studies, by accepting to enroll into ASP I am at the same time excluding any other conflicting opportunity. I am aware that I have to attend all the ASP courses and participate to the ASP Multidisciplinary Project.</li> <li>ASP enrolment is limited to 150 students. If I withdraw from ASP after the Opening ceremony, understand that no other student can be admitted to replace me, causing a net loss both to ASI and to those students who did not have the opportunity to be admitted.</li> <li>ASP Benefits cannot be combined with other financial aid such as the Regional Agency for the Right to Education of Piedmont (EDISU), the Ministry of Foreign Affairs and International Cooperation (MAECI) and the TOPoliTO scholarship, etc. Other scholarships granted by internation or external institutions may not be compatible with ASP benefits. If I have applied for these benefits I am aware that I have to inform both the ASP office and the office in charge of granting these benefits.</li> </ul>
