The replacing candidates shall proceed with the on-line enrolment though the Apply procedure by 4th March 2024.

At the end of the online enrolment process, applicants need to book an appointment <u>between 5th</u> <u>and 8th March 2024</u> with the staff of the PhD Programmes Hub from the Teaching Portal (*Booking tool*) for the second phase of the enrolment process.

The applicant must come to the PhD Programmes Hub and present:

- a) a photocopy of the identity card or passport;
- b) original English language certificate, as required by art. 6, par. 1 letter b;
- c) Bachelor's degree certificate + Master's degree certificate + transcript of records of the exams written in one of the languages specified in art. 7, par. 2, letter b (if the degree was awarded by a foreign university).

The enrolment process ends with the delivery of the Polito Smart Card to the Ph.D. candidate.

In the event that the Ph.D. candidate cannot be in Turin by the deadlines to complete the second phase of the enrolment process in person, he/she must promptly inform the PhD Programmes Hub and provide a duly justified request to complete the second phase of the enrolment process remotely; in any case, the remote enrolment should be completed by 8th March.

Ph.D. candidates who have completed the second phase of the enrolment process through the Virtual Desk are enrolled "with condition" and must present themselves for the delivery of their documents at the offices of the PhD Programmes Hub by 31st May 2024. Failure to arrive in Turin and present the documents by the deadlines will be considered as renunciation of the Ph.D. position.
