

Amendment to the Call for applications for admissions to: the Bachelor's degree programme in Design and Communication - the Bachelor's degree programme in Territorial, Urban, Environmental and Landscape Planning – the Bachelor's degree programmes of the Engineereing area - the Professional Bachelor's degree programme in Industrial Manufacturinbg Technolgies a.y. 2024/25

THE RECTOR

Having considered the communication sent by the National Conference of University Delegates for Disability (hereinafter referred to as CNUDD) to the General Directorate of Higher Education and of the Right to Study of the Ministry of University and Research, regarding the opportunity, for the purpose of taking the admission test, to accept also medical certificates of specific learning disorders (hereafter referred to as SpLD) issued more than three years ago, due to limitation of the activity of the Health Care System caused by the COVID-19 pandemic in the renewal of SpLD certificates;

Having considered that it is advisable to follow the recommendations of the CNUDD;

Having acquired the favourable opinion of the Vice Rector for Education and of the Rector's Advisor for Social Assistance, Social Integration and the Rights of Persons with Disabilities regarding the possibility of accepting also SpLD certificates issued more than three years ago, for all tests for admissions to all Bachelor's degree programmes offered by Politecnico, provided that the applicant:

- self-certifies that he/she is on waiting list for certificate renewal;

- formally undertakes to submit the new certificate as soon as it becomes available, uploading it to the online platform;

DECREES

Art. 1 – that the provisions of the Call for applications for admission to the Bachelor's degree programmes of Politecnico di Torino (Rector's decree no. 1296 of 22/12/2023) are amended as follows:

- 1.1 Applicants with a diagnosis of SpLD who have a medical certificate issued more than three years ago are admitted to take the admission test for a.y. 2024/25 (TIL test) provided that they:
 - self-certify that they are on waiting list for certificate renewal;
 - formally undertake to submit the new certificate as soon as it becomes available.
- 1.2 applicants mentioned in point 1.1 above who participated in the "Progetto Orientamento Formativo" and then took the TIL test in the specific session scheduled for the project participants, without having been able to take advantage of the special arrangements and/or extra time, are allowed to register for a new TIL test session, under the same economic conditions provided by the project itself.



- 1.3 applicants mentioned in point 1.1 above who participated in the "Progetto Orientamento Formativo" and decided not to take the TIL test in the specific session scheduled for the project participants, are allowed to register for a new TIL test session without having to pay the registration fee again.
- 1.4 applicants referred to in points 1.2 and 1.3 above are allowed to retake the TIL test according to the general rules of the test (i.e., possibility to take the test no more than three times totally), as provided for in the Calls for applications for admissions to the Bachelor's degree programmes, referred to in Rector's Decree no. 1296 of 22/12/2023.

Art. 2 – The same opportunities referred to in art.1, point 1.1 will also be offered to the applicants who will apply to the Call for applications for admission to the Bachelor's degree programme in Architecture that will be published in the near future.
