PART I – TUITION FEES

SECTION I – Introduction

Article 1 – General provisions

- 1. These Regulations, adopted within the meaning of Article 17 of the Student Regulations, establish:
 - a. the tuition fee amounts (from now on referred to as tuition fees);
 - b. the criteria to get tuition fee reduction, exemption and benefits;
 - c. the deadlines, methods of payment and reimbursement of tuition fees, together with debt collection in case of unpaid tuition fees;
 - d. the controls and sanctions on self-declared economic data provided by applicants for tuition fee reduction.
- 2. The provisions of these Regulations apply to:
 - a. students enrolled in Bachelor's and Master's degree programmes belonging to the system established by Ministerial Decrees no. 509/99 and no. 270/04);
 - students enrolled in Bachelor's degree programmes and courses for the attainment of a university diploma "Diploma Universitario" (belonging to the system pre-dating Ministerial Decree. no. 509/99);
 - c. Ph.D. candidates and students of Specialization Schools (Scuole di Specializzazione), as long as these rules comply with the special provisions for such Schools;
 - d. students enrolled in single courses, including students who come from non-Italian universities, with or without exchange programme.

3. Tuition fees include:

- a. Poli fees: yearly comprehensive fee (referred to in Article 1, paragraph 252 of Law no. 232 dated 11th December 2016). This fee is the amount that you are required to pay to cover costs of educational, scientific and administrative services offered by Politecnico. This fee varies according to the following conditions:
 - i. the type of enrolment workload you have chosen (full-time/part-time). The comprehensive fee is reduced by 40% for part-time enrolment.
 - ii. your contribution level calculated when you apply for tuition fee reduction;
 - iii. the number of years of enrolment. For the sole purposes of these Regulations, the number of years of enrolment is calculated as follows: one year of full-time enrolment is worth 1 year and part-time enrolment is worth a half year. If the result of the calculation contains decimals, numbers will be rounded down (for example, if the result is 4.5, 4 years will be counted).
 - iv. the number of CFU (credits) that you have earned;
 - v. any exemptions applied.

b. Extra-Poli fees.

- i. Regional tax for the Right to University Education EDISU (from now on referred to as regional tax): 140 €.
- ii. Enrolment revenue stamp: 16 €.
- iii. Premium for accident insurance: 5 €.

The above reported amounts may change due to updates made every year by the Institutions involved.

4. When you enrol for a new academic year, you undertake to pay your tuition fees to the University by the deadlines, regardless of the fact that you are actually using (or not using) teaching, scientific and administrative services, that you are progressing in your studies or that you have a hold on your academic progress. Payment may be divided into several instalments. If you intend to transfer out or

- withdraw from studies, you are exempted from paying the second instalment of your tuition fees if you submit your request before the second instalment deadline (see articles 10 and 11).
- 5. The provisions of these Regulations are approved by the governing bodies of Politecnico di Torino every academic year and available at the web page: https://www.polito.it/en/education/services-and-life-at-politecnico/right-to-education-and-tuition-fees/tuition-fees/.
- 6. All students are required to learn and act in accordance with the provisions of these Regulations.
- 7. For more information about tuition fees, you can check your personal page of the Teaching Portal > Online Services TAB > Tuition Fees and payments PORTLET > Pay your tuition fees.

SECTION II – Bachelor's and Master's degree programmes belonging to the system established by Ministerial Decrees no. 270/04 and 509/99, Bachelor's degree programmes and courses for university diploma "Diploma Universitario" belonging to the system pre-dating Ministerial Decree no. 509/99

Article 2 - Tuition fee maximum amounts for EU citizens or non-EU citizens residing in Italy

1. The tuition fee maximum amount for EU citizens or non-EU citizens residing in Italy is calculated as follows:

- 2. Based on these maximum amounts, you can apply for tuition fee reduction according to the provisions of Part II Section II.
- 3. If you are a non-EU citizen who reside in Italy, you must update your registered residence address on your Personal Page of the Teaching Portal > Online services TAB > View your data and change your address PORTLET > Personal Details > Current Address. This declaration must be updated as soon as the change of residence becomes effective and, in any case, no later than 31/12/2024 (for students enrolled in a Master's degree programme after 1/1/2025, the deadline is 31/07/2025). The residence address you declare will be checked by the Register Office of your declared Municipality: in the event that Politecnico becomes aware that the address you declared as your residence address is not

registered as such, you will have to pay the maximum contribution applicable for your home Country flat range payment scheme (article 3).

Article 3 – Tuition fees for non-EU citizens not residing in Italy

- 1. If you are a non-EU student not residing in Italy and your home Country is listed in Annex A (Least Developed Countries, as identified by the MUR Ministry of University and Research) with Ministerial Decree no. 440 of 13/02/2024), you are not required to pay the comprehensive fee (article 1).
- 2. If you are a non-EU citizen, not residing in Italy and your home Country is NOT listed in Annex A, you are required to pay a tuition fee amount based on the "flat range payment scheme".
 - a. The detail of the minimum and maximum fee amounts based on the flat range payment scheme (categorized on the basis of the Country of origin) is available in Annex B of the present Regulations.
 - b. If you are required to pay your tuition fees based on the flat range payment scheme, you can apply for tuition fee reduction according to provisions of Part II Section II. After requesting tuition fee reduction, you will be assigned the contribution level provided for by art. 34 and 35. In any case, the contribution level cannot be lower than the minimum flat range of your country of origin.

SECTION III – Enrolment in two higher education programmes at the same time (double enrolment)

Article 4 – Tuition fees for students enrolled in two higher education programmes at the same time

1. If in a.y. 2024/2025 you enrol in two higher education programmes, of which at least one at Politecnico di Torino, you are required to pay the following amounts:

2. In all other cases, you are required to pay the comprehensive fee without further reductions.

SECTION IV – Special cases

Article 5 – Tuition fees for students approaching the end of their university studies

- 1. If you are approaching the end of your studies and you comply with all the following conditions:
 - a. you pass all your exams by the end of the last examination session of a.y. 2023/2024;
 - b. you have included your internship in your Annual Personal Study of a.y 2023/2024 and the internship is registered in your transcript by 31st December 2024;
 - c. you have already included the thesis credits in your Annual Personal Study Plan of a.y. 2023/2024;

- d. you do not make a double enrolment in a.y. 2024/25 (enrolment in a Bachelor's degree programme in a.y. 2024/2025 and, after graduation, enrolment in a Master's degree programme in the same academic year Article 6).
- 2. If you comply with all the above-mentioned conditions, you can choose a full-time or a part-time workload. In both cases, when enrolling in the current a.y. you will have to pay € 361 (fixed fee).
- 3. You can apply for tuition fee reduction as provided in Part II Section II. You will be charged the most favourable amount if the amount due is lower than € 361.
- 4. If you are still waiting for the registration of your last exams, you must enrol in a.y. 2024/2025 in compliance with the deadlines and terms indicated in the Student Guide. When your last exams are registered in your transcript and therefore you fulfil the requirements to be considered as a graduand, you can request a review of your debit/credit situation via ticket (thought the Ticketing Support System available on your personal page of the Teaching Portal > Tuition Fees).

Article 6 – Tuition fees for students enrolling in a Bachelor's degree programme and in a Master's degree programme during the same academic year (2024/2025)

- 1. If you enrol in a Bachelor's degree programme in a.y. 2024/2025 and, after graduation, you enrol in a Master's degree programme in the same academic year (double enrolment), you must pay your tuition fees as follows:
 - a. when you enrol in the Bachelor's degree programme you must:
 - i. choose between a full-time or part-time enrolment workload. Please note that your Bachelor's enrolment workload must be the same as your Master's;
 - ii. pay the first instalment.
 - b. when you register for the Bachelor's Final Examination, you must pay the second instalment.
 - c. when you enrol the Master's degree programme, you will only pay the cost of the revenue stamp.
- 2. You must apply for tuition fee reduction (as referred to in Part II Section II) before registering for the Bachelor's Final Examination. You will not be able to apply for tuition fee reduction after enrolling in your Master's degree programme.
- 3. If you enrol in your Bachelor's degree programme over the fifth time in a.y. 2024/2025 and, after graduation, you enrol in a Master's degree programme during the same academic year, the extra charge (15/25%) applied to the second instalment of your tuition fees (in accordance with article 35) will be reimbursed after you enrol in your Master's degree programme.
- 4. If you meet the requirements referred to in article 34 (no-tax area) after you enrol in your Master's degree programme, your tuition fees are calculated as follows: extra-Poli fees + comprehensive fee due for your Bachelor's degree programme reduced by 50% + comprehensive fee due for your Master's degree programme reduced by 50%. The difference (if any) will be paid before the deadline for the second instalment.
- 5. If you receive an EDISU scholarship (article 29) in a.y. 2024/25 for enrolment in your Bachelor's degree programme but not for enrolment in your Master's degree programme, you must pay the comprehensive fee corresponding to your contribution level reduced by 50%.

Article 7 – Tuition fee for students transferring to Politecnico from another university and enrolling in a Master's degree programme in the second semester of a.y. 2024/2025

- 1. If you enrol for the first time in a Master's degree programme at Politecnico di Torino in second semester, you can choose between a full-time or part-time workload.
- 2. In both cases, you must pay the two instalments of your tuition fees as referred to in Part III Section I. You will be able to apply for tuition fee reduction as described in Part II Section II.

Article 8 – Tuition fees for students requesting to change from full-time to part-time workload or vice versa

- 1. Changing your APSP from full-time to part-time or vice versa is possible if you meet the requirements described in the Student Guide no later than 15/03/2025.
- 2. The difference (if any) will be paid before the deadline for the second instalment (article 42).

SECTION V – Other student charges

Article 9 – Other charges for individual services rendered upon request

1. Other administrative operations related to your university path require you to pay specific fees, listed in the table below and detailed in the following articles of this section.

Article 10 – Transfer out (congedo) to another university

- 1. If you apply for a transfer to another university (*congedo*) before 31st December 2024, you do not have to enrol at Politecnico for a.y. 2024/25. If you apply for a transfer to another university after 1st January 2024, you are required to enrol for a.y. 2024/25.
- 2. If you enrol for a.y. 2024/25 and apply for a transfer to another university (before the deadline of the second instalment article 42), you do not need to pay your second instalment for a.y. 2024/25.
- 3. If you apply for a transfer to another university before the deadline of the second instalment (article 42), but you have not been assigned your final contribution level for a.y. 2024/25, you must pay the first instalment of your tuition fees based on the highest contribution level (article 35), unless you have applied for tuition fee reduction before your transfer out application.
- 4. The fee charged for a transfer application is € 66.00 of which: € 50.00 for administrative fees and € 16.00 for the revenue stamp.

Article 11 - Withdrawal from studies

- 1. If you enrol for a.y. 2024/25 and request a withdrawal from studies before the deadline of the second instalment (article 42), you are not required to pay the second instalment of your tuition fees.
- 2. If you withdraw from studies before the deadline of the second instalment (article 42), but you have not been assigned your final contribution level for a.y. 2024/25, you must pay the first instalment of your tuition fees based on the highest contribution level (article 35), unless you have applied for tuition fee reduction before your withdrawal request.

Article 12 – Interruption and resumption of studies

- 1. If you intend to resume your studies after one or more years of interruption, you will have to:
 - a. settle possible outstanding debts deriving from your last year of enrolment;
 - b. pay a fixed fee (€ 100.00) for every year in which you have not been enrolled at Politecnico;
 - c. pay your tuition fees for the current a.y. as referred to in Part III Section I
- 2. If you do not complete your enrolment for the new academic year by 30/06/2025, you will have to pay an administrative fee (€ 100.00 for unfinished procedure) and the years of interruption will not be recognized.
- 3. If you also need to get the evaluation of your previous academic records, you must pay € 150.00. This amount will be deducted from your tuition fees if you enrol at Politecnico; otherwise, if you eventually decide not to enrol at Politecnico, it will not be refunded.

Article 13 - Suspension and resumption of studies

- 1. In order to request the temporary suspension of your studies you must have paid the tuition fees due for the last year of enrolment.
- 2. Exclusively in the event of personal/family problems, maternity/paternity, adoption, protracted hospitalisation or serious illness, you will be allowed to request the suspension of studies for the ongoing academic year. If you have enrolled for a.y. 2024/2025 and request the suspension of your studies by 31/03/2025, you do not have to pay the second instalment for a.y. 2024/2025.

Article 14 – New enrolment after withdrawal from studies (*rinuncia*), after forfeiture (*decadenza*), or enrolment in single courses – credit recognition

- 1. The cost for the recognition of the credits you earned during a previous university path (credit transfer after forfeiture, withdrawal from studies, enrolment in single courses) is due only if the previous academic career (for which the recognition has been requested) was NOT at Politecnico di Torino. This charge consists of:
 - a. A fixed fee (€ 150);
 - b. a variable fee for each validated credit (€16 per credit).

Article 15 – Transfer to Politecnico for enrolment in a Bachelor's or Master's degree programme – charge for unfinished procedure

- 1. If you are transferring to Politecnico from another university, you must pay the following charges to confirm your enrolment:
 - a. Entry transfer to a Bachelor's degree programme: € 161;
 - b. Entry transfer to a Master's degree programme: € 100.
- 2. If your transfer is completed successfully, this amount will be deducted from your tuition fees; otherwise, if you eventually decide not to enrol at Politecnico, it will not be refunded.

Article 16 - Credit transfer (abbreviazione carriera) - charge for unfinished procedure

- 1. If you have a university degree and you apply for credit transfer, you must pay € 100.00 at the beginning of the credit transfer process.
- 2. If you confirm your credit transfer, this amount will be deducted from your tuition fees; otherwise, if you eventually decide not to enrol at Politecnico, it will not be refunded.

Article 17 – Internal transfer – charge for unfinished procedure

1. If you apply for an internal transfer but you do not eventually confirm it, you will be charged a fee for the evaluation of your previous academic records (€ 50.00).

Article 18 – Evaluation of previous academic records for admission to a Master's degree programme – charge for unfinished procedure

- 1. If you are transferring from another university and you intend to enrol in a Master's degree programme at Politecnico di Torino, you must pay € 100.00 for the evaluation of your previous academic records. If you are admitted to Politecnico and you confirm your enrolment, this amount will be deducted from your tuition fees; otherwise, it will not be refunded.
- 2. You are exempted from paying the above-mentioned amount if:
 - a. you come from Università degli Studi di Torino and you apply for admission to the Master's degree programme in Digital Skills for Sustainable Societal Transition (LM-91) or to the Master's degree programme in Landscape Architecture (LM-3);
 - b. you are a prospective student with Ukrainian citizenship and residence permit for temporary protection in Italy.

Article 19 - English language exam registration fee

- 1. The registration fee to take the English language exam (IELTS exam) in the sessions organized at Politecnico di Torino in cooperation with an external Examination Board is € 164.90.

Article 20 – Italian language exam registration fee

- 1. Politecnico organises the PLIDA exam for its students in cooperation with Società Dante Alighieri. The costs for the PLIDA exam are the following:
 - a. € 114,07: full exam
 - b. € 30, 50: one single test
 - c. € 54,90: two single tests
 - d. € 73,20: three single tests

Article 21 – Application fee for students applying to the Master's degree programmes in: Nanotechnologies for ICTs (international major MNIS), Physics of Complex Systems (international major) and Industrial production and Technological Innovation Engineering

If you are on in the ranking lists for admission to the Master's degree programmes in Nanotechnologies for ICTs (international major MNIS), Physics of Complex Systems (international major) and Industrial production and Technological Innovation Engineering, you must reserve your student place by paying:
 - a. € 161 if you are from Politecnico di Torino.
 - b. € 61 if you are an applicant from another university.
- 2. The amount paid will be deducted from the overall amount of the tuition fees upon enrolment but cannot be refunded under any circumstances.

Article 23 – Tuition fees for students enrolled in Ph.D. programmes and in Specialization Schools

- 1. According to the law, if you enrol in a in Ph.D. programme or in the Specialization School "Architectural and Landscape Heritage", with or without a scholarship, you must pay exclusively the Extra-Poli fees (articles 1 and 25).
- 2. Further tuition fee exemption cases are listed in articles 25 and 26.

SECTION VII – Enrolment in Single Courses

Article 24 - Tuition fee for students enrolling in Single Courses

- 1. If you enrol in Single Courses, you do not need to pay the comprehensive fee and the Regional Tax (article 1), but you must pay a lump-sum upon enrolment as stated below:
 - a. a fixed fee (€361 including revenue stamp and premium for accident insurance);
 - b. a variable fee (€ 16 for each credit that you want to purchase).
- 2. If you have the refugee status or subsidiary/humanitarian protection and enrol in single courses, you are exempted from paying the above-mentioned fees. You will only have to pay the revenue stamp and the premium for accident insurance.
- 3. If you are enrolled in Single Courses, you cannot apply for tuition fee reduction.
- 4. If you have been admitted to a Master's degree programme and you need to make a double enrolment (i.e., you must first enrol in single courses in order to make up for your unfulfilled academic requirements, and then enrol in a Master's degree programme), the fee paid for Single Courses enrolment will be deducted from the tuition fees due for your Master's degree programme up to a maximum of € 345 (the € 16.00 revenue stamp cannot be deducted). The amount will be transferred to your student's virtual account before the deadline for paying the second instalment (article 42). This amount cannot be refunded if:
 - a. you have a full tuition fee exemption (Part II Section I);
 - b. you decide to eventually enrol in a Master's degree programme other than the programme you had initially chosen.

PARTE II – EXEMPTIONS, REDUCTIONS AND BENEFITS

SECTION I – Exemptions

Article 25 – Students with tuition fee exemption

1. If you are exempted from paying your tuition fees, by law or by Politecnico, you still have to pay the extra-Poli fees (article 1). Type of exemption and fees due are listed below:

Article 28 – ASP programme (Alta Scuola Politecnica) students

- 1. If you are participating in the ASP programme (Alta Scuola Politecnica), you do not have to pay your tuition fees for the entire duration of the programme (two academic years) (article 25).
- 2. If you lose your ASP student status:
 - a. you must pay your tuition fees retroactively (i.e. for the years in which you had a full tuition fee exemption). Given all the above, we suggest you apply for tuition fee reduction as referred to in Part II Section II;
 - b. you will be informed by an official e-mail sent to your PoliTo mailbox. You must pay your tuition fees within 30 days of receipt of the above-mentioned e-mail.
- 3. If you enrol in a Politecnico Bachelor's degree programme in a.y. 2024/2025 and, after graduation, you enrol in a Master's degree programme in the same academic year (double enrolment) with the ASP student status, you will be reimbursed the second instalment of the tuition fees.

Article 29 - Students applying for EDISU benefits

- 1. EDISU Piemonte, Ente Regionale per il Diritto allo Studio Universitario del Piemonte (Regional Institution for University right to education), is an institution of Regione Piemonte that is responsible for fostering the right to university study through the provision of benefits for particularly deserving disadvantaged students (for the purposes of these Regulations, the scholarship is taken into special consideration). EDISU also provides other services to the whole student community. Full information and contacts are available at https://www.EDISU.piemonte.it/it.
- 2. If you apply for an EDISU scholarship (you need to provide the financial paperwork required by EDISU as referred to in the EDISU call for application), you do not need to apply for tuition fee reduction at Politecnico di Torino. When you apply for an EDISU scholarship, you are automatically assigned a contribution level that corresponds to the value of the ISEE Universitario/ISEE Parificato that you have submitted to EDISU. EDISU automatically sends your data to Politecnico. If you are not eligible for a scholarship as a result of inconsistencies in the financial documentation submitted to EDISU, but you still intend to apply for tuition fee reduction from Politecnico please make a specific request as referred to in Part II Section II.
- 3. If you enrol in two higher education programmes at the same time (article 4) and one of the two programmes is offered by a university located outside Piemonte, you must apply for tuition fee reduction to Politecnico (Part II Section II).
- 4. If you are awarded an EDISU scholarship or are eligible for it (*vincitore/idoneo*), you are exempted from paying your tuition fees (except for the revenue stamp and premium for accident insurance see article 1).

- a. If you are a first-year student (i.e. you are enrolled in first year of a Bachelor's or Master's degree programme) you can claim a refund (article 45) of the Regional Tax for the Right to University Education as soon as you meet the merit requirements listed in the specific EDISU Call for applications.
- b. If you are a continuing student (enrolling at Politecnico after first year in a Bachelor's or Master's degree programme or to a Ph.D. programme or to a Specializing School programme) you can claim a refund (article 45) of the Regional Tax for the Right to University Education as soon as the final scholarship ranking list is published by EDISU.
- 5. If last year you received a scholarship or you were eligible for a scholarship (*vincitore/idoneo*), you must declare that you have already applied or you are going to apply for an EDISU scholarship for this academic year when you enrol in a.y. 2024/25.
 - a. If you are going to apply for a scholarship for this academic year or if you declare that you have applied for it, you must enrol and pay the revenue stamp and the premium for accident insurance. Your effective eligibility for the scholarship will be confirmed only after the publication of the EDISU ranking list. If you do not get the scholarship, you will have to pay your tuition fees according to your contribution level.
 - b. If you declare that you have not applied nor you are going to apply for a scholarship for this academic year, you can apply for tuition fee reduction to Politecnico in accordance with these Regulations, Part II Section II.
- 6. If your EDISU scholarship is revoked or if you renounce your EDISU scholarship, please note that:
 - a. you will be required to pay your tuition fees for the year of revocation or renunciation in accordance with your contribution level. You will be informed by an official e-mail sent to your PoliTo mailbox. You must pay your tuition fees within 30 days of receipt of the abovementioned e-mail.
 - b. If you are in the following conditions:
 - i. you are a non-EU citizen not residing in Italy, and
 - ii. you are enrolled for the first time in a.y. 2024/25 in a Bachelor's degree programme or in a Master's degree programme, and
 - iii. your EDISU scholarship for a.y. 2024/25 has been revoked because you do not meet the merit requirements listed in the specific EDISU Call for applications

you will be required to pay your tuition fees in accordance with the "flat range payment scheme" (article 3, Annex B). However, if you earn at least 10 CFUs by 10/08/2025, you must pay the contribution in accordance with the amounts listed in articles 33 and 34.

7. Politecnico can place or remove a hold (block) on your academic progress upon request of EDISU if you have any outstanding debt with this institution.

SECTION II – Tuition fee reduction

Article 30 - Tuition fee reduction - Introduction

- 1. If you are enrolled in a Bachelor's degree programme or in a Master's degree programme, you can get a tuition fee reduction provided that you apply for it as referred to in this Section. You must submit your application for tuition fee reduction every academic year.
- 2. Tuition fee reduction is based on 75 contribution levels.
- 3. You can apply for tuition fee reduction upon enrolment (see article 32) or at a later stage (article 33).
- 4. You need to have an ISEE declaration issued by INPS for "prestazioni per il diritto allo studio universitario" (services for the right to university education) in order to fill out your application. Other

types of ISEE (such as ISEE Ordinario/standard ISEE and ISEE Socio Sanitario/health and social ISEE) are NOT accepted. For more information on the types of ISEE declarations is available at: <a href="https://www.polito.it/en/education/services-and-life-at-politecnico/right-to-education-and-tuition-fees/

- 5. You can get a tuition fee reduction if your family's Equivalent Economic Situation Indicator (ISEE) does not exceed the following maximum amounts:
 - a. Equivalent Economic Situation Indicator (ISEE) (ISEE Universitario/ISEEU/ISEEUP): ≤ € 85,500.
 - b. Equivalent Property Situation Indicator (ISPE/ISPEU/ISPEUP): ≤ € 210,000.

The ISPE/ISPEU/ISPEUP Indicator is calculated by dividing the ISP (Property Situation Indicator) by the Equivalence Scale (SE). This indicator is not considered if you meet the requirements of the notax area (article 34).

- 6. After submission, the application is valid for the entire a.y. 2024/2025 and can only be changed if you present your ISEE Corrente before the deadlines of article 33.
- 7. For any inquiries, you can send a ticket (through the Ticketing Support System of your personal page of the Teaching Portal > "Tuition Fees" topic).

Article 31 - Incomplete or inconsistent ISEE declarations

- 1. If you apply for tuition fee reduction but you present an incomplete or inconsistent ISEE declaration:
 - a. your ISEE declaration will be provisionally accepted and you will be assigned a provisional contribution level;
 - b. you will receive an official e-mail to your PoliTo mailbox. Within 30 days of receipt, you can:
 - i. provide a new ISEE declaration without any omissions/inconsistences. No sanctions will be imposed on you if your final contribution level is different from your provisional level;
 - ii. provide the supporting documents that prove that your first ISEE declaration was actually correct and truthful. To do this, send a ticket (thought the Ticketing Support System of your personal page of the Teaching Portal > "Tuition fees" topic).
- 2. If you do not submit the documents referred to in point i and ii before the deadline, you will irrevocably be assigned the highest contribution level.

Article 32 – Applying for tuition fee reduction upon enrolment

- 1. You can apply for tuition fee reduction when you enrol in the new academic year:
 - a. if you present a valid ISEE Universitario or an ISEE Corrente, you give your consent to query the INPS database to retrieve your data.
 - b. if you present an ISEE Parificato (article 30), you need to confirm your economic data submitted last year.
- 2. If you do NOT give your consent to allow Politecnico to query the INPS database, or if you do NOT confirm your previous economic data, you can still apply for tuition fee reduction after enrolment (article 33).

Article 34 - No-tax area

- 1. Within the meaning of Law no. 232 of 11th December 2016, Ministerial Decree no. 1014 of 3rd August 2021 as integrated by the following resolutions of the Board of Directors no. 86 of 30th March 2017, a no-tax area has been established. The no-tax area extends the full tuition fee exemption from € 22,000.00 to € 25,000.00 and the partial exemption from € 30,000.00 to € 30,500.00.
- 2. This exemption is applied to the comprehensive fee. In any case, you must pay the extra-Poli fees (article 1).
- 3. If you are enrolled in a Bachelor's or Master's degree programme, both part-time and full-time, and meet all the requirements listed in the table below (income, number of earned credits, number of years of enrolment), you can be included in this payment scheme. Your ISPE value (Indicatore della Situazione Patrimoniale Equivalente, see article 30) is not relevant. For the purposes of verifying if you fulfil the requirements, the number of years of enrolment will be calculated as referred to in article 1.

4. The tuition fees (including comprehensive fee and extra-Poli fees – article 1) are listed in **Annex C**. Please note that there are two instalments and they are based on type of enrolment workload (full-time or part-time).

Article 35 – Part-time or full-time students applying for tuition fees reduction

- The tuition fees (including comprehensive fee and extra-Poli fees article 1) are listed in Annex D for students who:
 - a. are enrolled beyond the second time but within the standard graduation timeline plus one year (fourth enrolment in a Bachelor's degree programme, third enrolment in a Master's degree programme), and
 - b. meet the merit requirements but do NOT meet the economic requirements (ISEE Universitario/Parificato > € 30,500.00) for the no-tax area (article 34).

Please note that there are two instalments and they are based on the type of enrolment workload (full-time or part-time).

2. The tuition fees (including comprehensive fee and extra-Poli fees – article 1) are listed in **Annex E** for students who:

- a. are enrolled in a Bachelor's degree programme for the 5th time or in a Master's degree programme for the 3rd time, and
- b. DO NOT meet the requirements for the no-tax area (article 34).

Please note that there are two instalments and they are based on the type of enrolment workload (full-time or part-time).

- 3. The tuition fees (including comprehensive fee and extra-Poli fees article 1) are listed in **Annex F** for students who:
 - a. are enrolled in a Bachelor's degree programme for the 6th time or in a Master's degree programme for the 4th time, and
 - b. DO NOT meet the requirements for the no-tax area (article 34).

The tuition fee amounts shall be increased by 15% over the standard amount referred to in paragraph 2. Please note that there are two instalments and they are based on the type of enrolment workload (full-time or part-time).

- 4. The tuition fees (including comprehensive fee and extra-Poli fees article 1) are listed in **Annex G** for students who:
 - a. are enrolled in a Bachelor's degree programme with over 6 enrolments or in a Master's degree programme with over 4 enrolments or in a degree programme belonging to the system pre-dating Ministerial Decree no. 509/99 (and ISEE Universitario/ Parificato ≤€ 150,000.00)
 - b. DO NOT meet the requirements for the no-tax area (article 34).

The tuition fee amounts shall be increased by 25% over the standard amount referred to in paragraph 2. Please note that there are two instalments and they are based on the type of enrolment workload (full-time or part-time).

- 5. The tuition fees (including comprehensive fee and extra-Poli fees article 1) are listed in **Annex H** for students who:
 - a. are enrolled in a Bachelor's degree programme with over 7 enrolments or in a Master's degree programme with over 5 enrolments or in a degree programme belonging to the system pre-dating Ministerial Decree no. 509/99 (and ISEE Universitario/Parificato > € 150,000.00)
 - b. DO NOT meet the requirements for the no-tax area (article 34).

The tuition fee amounts shall be increased by 50% over the standard amount referred to in paragraph 2. Please note that there are two instalments and they are based on the type of enrolment workload (full-time or part-time).

Article 36 - Technical and Administrative Staff, Library Staff and Technologists of Politecnico di Torino

1. Within the framework of its staff training policy, Politecnico offers its Technical and Administrative Staff, Library Staff and Technologists a comprehensive fee reduction (excluding extra-Poli fees) in accordance with the provisions of a specific university Call for applications for Bachelor's and Master's degree programmes.

SECTION III – Benefits

Article 37 - Tuition fee reduction based on academic merit

- 1. If you are enrolled in a Bachelor's or in a Master's degree programme and you have a high academic performance (measured with the score described below), you classify as a high-achieving student. In this case, you can get a benefit of € 200.00.
- 2. This benefit is recognized in one of the following ways:

- a. a reduction in the comprehensive fee (not including the extra-Poli fees, article 1), provided that the comprehensive fee that you have to pay depending on your final contribution level is ≥ € 200.00).
- b. A scholarship, if your comprehensive fee is lower than € 200.00. You are required to choose a payment method based on the instructions reported in article 45.

The calculation of your benefit is based on your final contribution level or, if this is still unavailable, on your provisional contribution level. When your final contribution level becomes available, possible adjustments are applied to the second instalment of your tuition fees, after 14th March 2025. If, upon enrolment/registration, the first instalment is fully covered by the benefit, the revenue stamp is still due.

- 3. In order to calculate your merit score, Politecnico considers the exams that you pass before 10th August 2024. The score is calculated as follows:
 - a. multiply the number of credits of each exam by its grade. Please consider that pass-or-fail exams are assigned the weighted average grade of the other graded exams.
 - b. add the results of these products.

The following exams do not count towards the score:

- c. any exams passed to make up for your unfulfilled academic requirements;
- d. exams taken during a previous university path, although already recognized by Politecnico;
- e. exams that normally do not count towards the attainment of the final degree.
- 4. The minimum score that you need to have to get the merit-based reduction is:
 - a. at least 1210 points if you are a first-year student in a.y. 2023/2024, or
 - b. at least 1455 points if you are a continuing student (enrolled in year two or beyond).
- 5. You are entitled to obtain the merit-based reduction if you are enrolled at Politecnico as a full-time student for a.y. 2024/2025.
- 6. You can get the merit-based tuition fee reduction:
 - a. for no more than three times if you are enrolled in a Bachelor's degree programme (the third reduction is possible only if you have already enrolled in a Master's degree programme)
 - b. just once if you are enrolled in a Master's degree programme.

- 7. This process (calculation of your merit score and refund on your virtual account or scholarship payment) is automatic.
- 8. Special cases.
 - a. If in a.y. 2024/2025 you withdraw from studies or transfer out to another university before the deadline for paying your second instalment, the merit-based reduction cannot be higher than the comprehensive fee you actually paid for the first instalment.
 - b. If you make a double enrolment for a.y. 2024/25 (i.e., you first enrol in a Bachelor's degree programme and then you enrol in a Master's degree programme, article 6):
 - i. you will obtain the merit-based reduction after enrolment in your Master's degree programme.
 - ii. the merit-based reduction will be revoked if you withdraw from studies before 30th June 2025.

- c. If in a.y. 2024/2025 you enrol in two-degree programmes at Politecnico (article 4), you can obtain the merit-based reduction for only one programme.
- 9. You cannot get the merit-based tuition fee reduction if:
 - a. you have a part-time enrolment workload;
 - b. you have a university degree and enrol in a degree programme of the same level (for example if you have a Bachelor's degree and you want to enrol in a Bachelor's degree programme at Politecnico);
 - c. you are enrolled in a programme with specific economic regulations;
 - d. you get a scholarship and/or a grant awarded by Politecnico that has been declared non-cumulative with other financial benefits awarded by Politecnico for the same academic year.

Article 38 – Outgoing students: calculation of academic merit for the attribution of the benefits referred to in article 34 and 37

- 1. If you are an outgoing student participating in a mobility programme abroad or in a specific international educational path, some of the exams that you took abroad may not be recorded by 10/08/2024. In this case Politecnico calculates your merit score for the attribution of the benefits referred to in article 34 (no-tax area) and in article 37 (merit-based reduction) in accordance with the criteria mentioned below:
 - a. if your mobility programme ends before 10/08/2024, your merit score is calculated on all validated exams.
 - b. if your mobility programme ends after 10/08/2024, your merit score is calculated proportionally to the credits you earned during your mobility programme.
 - i. (total number of validated credits) / (total number of mobility days)
 - ii. (product of point i) x (number of days from the first mobility day up to 10/08/2024)
- 2. For the attribution of the benefits referred to in article 37, the credits calculated with the method described under paragraph 1.b are given a grade corresponding to the average grade of all the exams taken during the mobility programme and recognized by Politecnico.

Article 39 – Tuition fee reduction for Percorso Intraprendenti

- 1. If you are student of Percorso Intraprendenti and you are in your second or third year, you can get a reduction of the comprehensive fee amount (except for the extra-Poli fees, article 1) or a scholarship. Please note that this is subject to the availability of specific project funds.

PART III – TUITION FEE PAYMENT, REIMBURSEMENTS, DEBT COLLECTION

SECTION I – Tuition fee payment

Article 40 - Student virtual account

1. When you enrol at Politecnico, you establish a system of economic relations similar to a bank account with Politecnico. This economic relation system is called "student virtual account". This means that when you pay something to Politecnico (i.e., when you pay the second instalment of your tuition fees, when you pay for a replacement smart card ...), you owe money to Politecnico; on the other hand, under other circumstances you can become a creditor of Politecnico (i.e., if you obtain tuition fee reduction for academic merit).

- 2. You can check your virtual account by logging in to your personal page of the Teaching Portal > Online services TAB > Tuition fees and payments PORTLET > Pay your tuition fees.

Article 41 – Tuition fee payment options

- 1. All payments must be made through the PagoPA platform available at Online Services TAB > Tuition fees and payments PORTLET > Pay your Tuition fees.
- 2. You can choose one of the following payment methods:
 - a. Quick payment: credit card, online bank transfer or any other available payment method. Please note: the PagoPA platform (online electronic payment to the Public Administration) may not authorize payments by credit card if the amount is over € 1,000.00. In this case, you will have to make various partial payments. You will have to type the amount of each partial payment in the corresponding field ("importo versamento").
 - b. Deferred payment: you must generate a MAV (Modulo Avviso Pagamento / electronic deposit slip). You can pay your MAV at any bank counter or through the online banking service of your bank. The payment is automatically recorded within 24-48 hours of the date of payment. Regarding this type of payment, we remind you that:
 - i. For any operation requiring a simultaneous payment (for instance, first enrolment/enrolment for a new academic year, Final Examination registration) you must declare the date of payment: log in to the enrolment/registration procedure again and click the "Register MAV" button;
 - ii. If you pay your MAV after 5.00 p.m., the bank might not record your payment on the same day (you must verify with your bank their recording schedule): in this case Politecnico will charge you a late penalty fee.

Article 42 - Application deadlines for tuition fee payment

1. The tuition fees must be paid in two instalments, except for students approaching the end of their university studies (article 5), who must pay one instalment only upon enrolment. Please check the table below to learn about the deadlines.

Article 43 – Failure to pay or late payment of tuition fees – hold on your academic progress

1. If you do not pay your tuition fees by the deadline for the second instalment, or if you pay less than the amount due, a hold will be placed on your academic progress and you will not be able to perform any further operations (exams, withdrawal from studies, certificates, self-declarations, etc.). If you are placed on a hold, all your exam bookings will be cancelled. The hold will be removed upon full payment of your outstanding debts.

- The fee charged for removing the hold is € 10, if you pay within the first 15 days of the deadline; this
 fee will not be charged if your second instalment is lower than 20€. If the payment takes place after
 the 15th day, you will also be charged an additional cost (10% of your debt).
- 3. The fee charged for removing the hold must be paid by 31/05/2025 (or before the registration deadline for the Final Examination, if this is earlier).
- 4. You will receive an e-mail into your PoliTo mailbox informing you about the hold and the amount charged for removing the hold.
- 5. You will have to pay your outstanding debts even if you incur in forfeiture.

Article 44 - Failure to pay or late payment of other debts/charges - hold on your academic progress

- 1. All outstanding debts in your virtual account (for example: costs for a replacement smart card, fees for removing the hold, etc.) must be settled by 31/05/2025 (or before the registration deadline for the Final Examination, if this is earlier). If you do not pay your outstanding debts, a hold will be placed on your academic progress and you will not be able to perform any further operations (exams, withdrawal from studies, certificates, self-declarations, etc.). If you are placed on a hold, all your exam bookings will be cancelled. The hold will be removed upon full payment of your outstanding debts.
- 2. You will receive an e-mail into your PoliTo mailbox informing you that you are placed on a hold.
- 3. You will have to pay your outstanding debts even if you incur in forfeiture.

SECTION II – Reimbursements

Article 45 - How to claim a refund

- 1. If your virtual account (article 40) has a credit balance, you can claim a refund by clicking on the "Refund Application" button available on your personal page of the Teaching Portal > Online Services TAB Tuition fees and payments PORTLET Pay your tuition fees.
- 2. In any case, at the end of each academic year, Politecnico will refund all students who have graduated during the year and who are not continuing their studies at Politecnico, if their virtual account has a credit balance.
- 3. You can receive a reimbursement from Politecnico only if you have chosen a payment method by entering this information on your personal page of the Teaching Portal > Online Services TAB > Tuition fees and payments PORTLET > Enter your payment modality to receive money from Politecnico. The options for reimbursement are the following:
 - a. Bank or Bancoposta transfer: you must be the holder or co-holder of a bank account and you must enter its IBAN code to receive the refund. This is the preferable method, as it guarantees you to receive your credit quickly.
 - b. Cash: as soon as cash is available, you will receive an e-mail in your PoliTo mailbox with the instructions for collecting your reimbursement. To collect the money you must go to any UniCredit bank counter with your identity card and your fiscal code. If your credit is € 1,000.00 or greater, money can be refunded by bank transfer only, in accordance with Article 12 of Decree-Law No. 201 of 6th December 2011 and further modifications.
- 4. If you do not enter your bank details correctly or if you do not withdraw your cash by the deadline, a new refund is not automatic and you need to make a new refund request.

SECTION III – Debt collection

Article 46 – Debt collection actions

- 1. When you enrol in the new academic year you undertake to pay your tuition fees to Politecnico within the deadlines. For this reason, if you have some outstanding debts (not paid by the deadlines referred to in articles 42, 43 and 44) Politecnico will take all the necessary actions to collect the debt. Please note that Politecnico will collect the debt even if you are not actually using any educational, scientific and administrative service, if you have a hold on your academic progress or if the payment can be divided into several instalments (article 1).
- 2. Debt collection will be carried out in the first instance by sending a notice of payment by registered mail to your permanent address, or if available by PEC. The notice will contain the details of the debt and the deadline for its payment. Once the payment deadline specified in the notice has unsuccessfully expired, Politecnico will take appropriate judicial and enforcement actions aimed at collecting the amount due.

SECTION IV – INSPECTIONS, VERIFICATIONS AND SANCTIONS

Article 47 - Self-certificate verifications

- The ISEE Universitario/Parificato declaration used for your application for tuition fee reduction is a regular self-certificate and requires you to be fully accountable for the truthfulness of your declarations (Presidential Decree No. 445 of 28th December 2000). Within the meaning of article 76 of this decree, if you make false declarations, produce or use untrue data, you are punished in accordance with the penal code and other specific provisions.
- 2. The self-certificate could be subject to a sample inspection in accordance with the current legislation in force.
- 3. Once the verification process has begun, it cannot be stopped (even if, for example, you spontaneously renounce your undue benefits).
- 4. If you are selected for an inspection, you will receive a notice by registered mail, or if available by PEC, and you will also be informed via e-mail into your PoliTo mailbox. By the same means, Politecnico will ask you to provide the necessary information. The result of this verification and any decisions taken in case of irregularities will be communicated by the same means as well.
- 5. These decisions are open to an internal appeal to the Head of the Department or Unit conducting the verifications (or to any other purposely appointed responsible person).

Article 48 - Sanctions

- 1. If you make false, incomplete or inconsistent declarations, you will be subject to:
 - a. refund the undue benefits;
 - b. pay an administrative penalty (three times greater than the benefit) in accordance with paragraph 3 of article 10 of Legislative decree no. 68 of 29th March 2012;
 - c. pay an additional penalty in accordance with paragraph 3 of article 38 Legislative Decree converted into Law no. 122 of 30/07/2010. The penalty amount may be included between € 500.00 and € 5,000.00 calculated proportionally to the undue benefit.
- 2. The Rector will be informed in order to send appropriate reports to the competent authorities for the possible application of further measures and actions provided for by current legislation and by internal University regulations.

PART V – COMMON AND FINAL PROVISIONS

Article 49 - Processing of personal data

- In accordance with the General Data Protection Regulation (EU Regulation 2016/679) and the Code regarding the protection of personal data (Legislative Decree No. 196 of 30th June 2003 and further amendments, Politecnico di Torino will process your personal data in pursuit of its institutional aims and in accordance with the transparency purposes imposed by the law. The processing of personal data is based on the principles of correctness, lawfulness and relevance of purposes.

Article 50 – Information and participation in administrative proceedings

- 1. Communication between Politecnico and students takes place primarily through the PoliTo mailbox assigned to each student upon enrolment.
- 2. To contact the offices of Politecnico you need to use the Ticketing Support System available on your personal page of the Teaching Portal (Portale della Didattica).

Article 51 - Final Provisions

- 1. In accordance with the Student Regulations (article 21, paragraph 1), instances concerning your tuition fees may be raised to the Rector or to his/her delegate, who in response may avail him/herself of a purposely appointed Commission.
- 2. In the event of changes in the procedures or terms of this Regulations (exclusively for technical and operational reasons) or changes in the tuition fee amounts due to external events (such as new revenue stamp costs imposed by the law after these Regulations are published), the person in charge is the Executive of the STUDI Department Student, Education and International Affairs.
