#### Art. 1 – Admissions to PhD programmes

- 1. The Call for applications for admissions to the PhD programmes of Politecnico di Torino is now open. Applications for the 41st cycle are invited for the following PhD programmes:
  - Architecture. History and Project, including the curriculum "Transnational Architectural Models in a Globalized World" in collaboration with the School of Architecture of Tsinghua University
  - Bioengineering and Medical-Surgical Sciences in collaboration with Università degli Studi di Torino, including the curriculum in collaboration with Kansai Medical University
  - Design and Technology. People, Systems and the Environment
  - **Energetics**
  - **Physics**
  - **Aerospace Engineering**
  - **Chemical Engineering**
  - Civil and Environmental Engineering
  - Electrical, Electronics and Communications Engineering, including the "Electronics Devices" curriculum, in collaboration with the National Institute for Nuclear Physics
  - **Management and Production Engineering**
  - **Computer and Control Engineering**
  - **Mechanical Engineering**
  - Patrimonio architettonico / Architectural Heritage
  - Materials Science and Technology
  - **Mathematical Sciences**
  - Urban and Regional Development in collaboration with Università degli Studi di Torino
- 2. The beginning of the above-mentioned PhD programmes of the 41st cycle is subject to prior accreditation by the Ministry of University and Research in compliance with current legislation. A possible negative outcome of the accreditation procedure and/or of the renewal of the aforementioned agreements, which would hinder the activation of the course, will be promptly communicated to the applicants through the Ticketing Support System as indicated in art. 20.
- 3. All PhD programmes will start at Politecnico di Torino on 1st November 2025 for successful applicants in the first session of the selection process, and on 1st March 2026 for successful applicants in the second session, as referred to in art. 5 and art. 7, par. 1 of the present Call.

#### Art. 2 - PhD positions

1. Politecnico di Torino makes available, for the 41st cycle, funding corresponding to a minimum of **96 PhD scholarships**, as per the table below:

The **definite number of positions** available for each session and each PhD programme will be finalized in the above-mentioned website **within 6 days before the date of the oral interview** set by the Admissions Committee and published in accordance with the provisions set in art. 10.

	ORDINARY PhD POSITIONS		
Fully-funded PhD positions (with scholarship) with own research topic	These fully-funded positions are not associated to a specific research topic. The topic will be decided in agreement with the Coordinator and the Supervisor of the PhD programme.  All applicants compete for scholarships with own research topic, unless they explicitly renounce their right to receive them.		
Fully-funded PhD positions (with scholarship) with predefined research topic	Applicants who receive an offer for this kind of PhD position are required to <b>compulsorily</b> conduct their research on a predefined research topic, as detailed in the information sheet published on the website.  Applicants interested in competing for this type of positions are required to select the research topics following the instructions and deadlines referred to in art. 4, par. 1.		
PhD positions offered in apprenticeship format	These positions offer the opportunity to conduct a research activity and get a PhD degree while being simultaneously employed by a company with an apprenticeship contract having the same duration of the PhD programme.  Applicants must be aged under 30 years when the company hires them.  The apprenticeship contract (stipulated in accordance with Legislative Decree no. 81/2015) is terminated upon completion of the PhD programme and/or degree conferral.  Applicants interested in competing for this type of positions are required to follow the procedure referred to in art. 4, par. 1.		
PhD positions without scholarships	These positions are not associated to any scholarship. Applicants who wish to undertake a PhD programme without receiving any scholarship are required to <b>follow the procedure referred to in art. 4</b> , <b>par. 2</b> .		

RESERVED PhD POSITIONS	
PhD positions reserved to recipients of scholarships granted by Governments or by national or foreign public bodies	These positions are offered to the applicants who are recipients of a scholarship funded by a Government or by a national/foreign public body and are declared eligible for admission at the end of the selection process based on the order of the ranking list (see art. 11 par. 8).
PhD positions with scholarships reserved to the POLITO for REFUGEES project	These positions are reserved for holders of international protection and are activated subject to the availability of internal and/or external funds. Applicants interested in this type of position must follow the instructions provided in Annex 1.

PhD positions reserved to specific international initiatives	These positions are reserved for applicants pre-selected by institutions/universities within the framework of international collaborations with the University and are activated subject to the availability of internal and/or external funds. In case of lack of available funds, these positions will not be activated.  Applicants interested in this type of position must follow the instructions provided in the information sheet of the scholarship.
PhD positions reserved to research fellows	These positions are offered to the applicants who are declared eligible for admission at the end of the selection process following the order of the ranking list (see art. 11 par. 8) and are already holders of a research grant (assegno di ricerca).  The number of positions reserved to research fellows is equal to half of the number of ordinary positions for each PhD programme, rounded up to the nearest unit.  The topic of the research fellowship and the topic of the PhD thesis must be the same.  The Academic Board may give a binding opinion on the compatibility of the two activities.  Research fellowships are not compatible with PhD scholarships.  Research fellows who are admitted to a PhD programme with a scholarship have two options:  a) give up their research fellowship and enrol in the PhD programme with a PhD scholarship;  b) keep their research fellowship and enrol in the PhD programme without

any PhD scholarship.

4. Employees of companies/institutions who intend to activate an Executive PhD position pursuant to art. 17, par. 5 of the Regulations for doctoral programmes currently in force must participate in the competition and result eligible for an ordinary PhD position without scholarship. The activation of PhD positions entails signature of a specific agreement between Politecnico and the company/institution, in which its cost will be defined.

### Art. 3 – PhD scholarships: nature and amount

- 1. PhD scholarships last one year and are renewed from year to year provided that PhD candidates have fulfilled the coursework requirements and have been admitted to the next year by the Academic Board. Scholarships are disbursed for a maximum of 36 months, unless otherwise provided by art. 36, par. 2 of the Regulations for doctoral programmes of Politecnico di Torino.
- 2. The gross annual amount of a PhD scholarship for the A.Y. 2025/26 is € 18.854,52, including social security contributions charged to the scholarship recipient. The net monthly rate is € 1.386,00 (unless welfare rates change). Scholarship recipients are exempted from paying the local income tax and the personal income tax (IRPEF). The scholarship amount is subject to the deductions of the INPS









contributions (Gestione Separata), two thirds of which are charged to Politecnico di Torino and one third is borne by the recipient. The amount of the scholarship will be increased by 50% proportionally to any periods of study and research abroad in accordance with current legislation. It also includes a budget for research activities available to the PhD candidate, equal to 10% of the total cost of the scholarship, to be used over the 36 months of activity.

- 3. The following categories of applicants cannot receive any PhD scholarship:
  - a) individuals who have already received a scholarship for a PhD programme in Italy;
  - b) civil servants who are on special leave but still receive their salary and social security contributions;
  - c) research fellows/assegnisti di ricerca (see art. 2, par. 2);
  - d) individuals who have a contract of "Alta Formazione e Ricerca" (art. 45 of Legislative Decree no. 81/2015).

## Art. 4 – How to accept or decline on offer of admission for a fully-funded PhD position with predefined research topic or for a PhD position offered in apprenticeship format

- 1. Applicants interested in competing for one or more PhD scholarships with predefined research topic and/or in any PhD positions offered in apprenticeship format must carefully check the research topic and competencies required to carry out the specific research project, illustrated in the information sheet of each scholarship (they can contact the Professor associated with the scholarship, if needed). They are also required to follow the online procedure available on the online application Apply@polito platform (see the following art. 7, par. 1) and select up to a maximum of 5 options starting from 5 days before the beginning of the interviews of the relevant PhD programme and until 12.00 p.m. (noon, CET time) of the day before the interview. It is specified that the starting date of the interviews is set by each Admissions Committee and communicated according to the procedures outlined in the subsequent art. 10.
- 2. Applicants who want to compete for a PhD position renouncing to all PhD scholarships (either with predefined research topic or with own research topic) or applicants who do not intend to compete for any PhD position offered in apprenticeship format must explicitly renounce their right to receive them. They are required to follow the on-line procedure available on the online application Apply@polito platform (see art. 7, par. 1) and select the scholarship-waiver option, starting from 5 days before the beginning of the interviews of the relevant PhD programme and up to 12.00 p.m. (noon, CET time) of the day before the interviews. Choices cannot be modified. It is specified that the starting date of the interviews is set by each Admissions Committee and communicated according to the procedures outlined in the subsequent art. 10.

It is understood that, if there are no PhD positions without scholarship, renouncing to all scholarships or PhD positions offered in apprenticeship format will result in application being rejected, with the exception of the PhD positions reserved to research fellows.

#### Art. 5 – Sessions of the Call

1. The PhD selection process for admissions to the PhD programmes of the 41st cycle is organized in two separate sessions, hereinafter referred to as "**first session**" and "**second session**".

#### Art. 6 – Admissions requirements

1. In order to apply for a PhD programme, applicants must meet the following requirements on the deadline for application submission for each session (art. 7, par. 1):

	Applicants with an academic qualification (2 <sup>nd</sup> level) obtained in Italy	Applicants with an academic qualification (2 <sup>nd</sup> level) obtained abroad
a)	Master's degree (Laurea Magistrale) or Laurea specialistica or academic degree belonging to the university system pre-dating M.D. no. 509 of 3 <sup>rd</sup> November 1999, as amended by M.D. no. 270 of 22 <sup>nd</sup> October 2004 – with minimum final grade: 95/110.	Academic qualification valid for admission to a PhD programme in their country (see the following par. 2) with the minimum average grade of the exams as illustrated in Annex 2.
b)	English language certificate – level B2, as defined by the Common European Framework of Reference for Languages (CEFR), among those indicated in the Annex 4, regardless of the date of conferral.  Certificates different from the ones listed in Annex 4 will not be accepted.  If one of the exemption cases from submitting the English language certification applies to students with an Italian or foreign degree, as indicated in Annex 3 of the Call, the submission of the language certification is not required.	

Applicants who still do not have the required academic qualification and/or the English language certificate on the deadlines indicated in art. 7, par. 1 are allowed to apply as long as they **meet both requirements by and no later than**:

- 31st October 2025 for participation in the selection process of the first session;
- 31st January 2026 for participation in the selection process of the second session.

In these cases, applicants can participate in the selection process "**under condition**". They are required to obtain their degree and/or the English language certificate before the above-mentioned deadlines otherwise **they will not be admitted to the PhD programme**.

These applicants must have an average grade of their Master's exams (GPA) higher than 25/30. In any case they must graduate with a minimum final grade of 95/110.

The lack of even one of the above-mentioned requirements a) and b) before the deadlines entails the exclusion from the selection process.

2. **Applicants with a non-Italian academic qualification** can be admitted to a PhD programme only if they have a second-level degree (as defined by the Bologna Process) or a Master' degree awarded by an officially recognized/accredited academic institution which grants admission to PhD programmes in the country of origin (level 8 EQF).

The University Board, referred to in art. 9, decides on the eligibility of non-Italian academic qualifications for the sole purpose of admission to the selection process for PhD programmes of the 41st cycle. The decision is based on the documents attached by the applicant to the application form (art. 7, par. 2).

This evaluation is possible only if the documents submitted by the applicant provide all the necessary information (type of degree, duration of the programme, official name of the university which

awarded the degree, date of degree conferral, grade etc.). The Board may not admit an applicant to the selection process if the documents do not provide enough information for evaluation.

#### Art. 7 – Application submission

1. Application forms must be submitted **no later than the deadlines indicated below**:

Applications must be submitted exclusively online through the **Apply@polito** platform available on the website of Politecnico di Torino. (https://www.polito.it/en/education/phd-programmes-andpostgraduate-school/admissions-to-phd-programmes/admissions/call-for-applications).

Applicants who log into the Apply@polito platform for the first time and do not have a Politecnico student ID number (s-number) are required to register to the Apply@polito platform.

Graduates and graduands from Politecnico di Torino must log into the Apply@polito platform through the Teaching Portal (https://didattica.polito.it/login) using their credentials (user: Snumber password: date of birth, in the format "ddmmyyyy" or changed password).

Application deadlines are mandatory. Late applications or applications submitted using a procedure different from the one specified in this paragraph will be rejected.

Politecnico di Torino encourages all applicants to submit their online applications ahead of the deadline. It is the applicants' responsibility to verify that the application process has been completed correctly, including the payment mentioned in par. 4 of this article. The University will not accept any claims for malfunctions of the online system due to network overloading close to the deadline.

## 2. Applicants are required to upload the following documents and information to their online application:

a)	A copy of a valid <b>identification document.</b>	Both front and back side with picture and signature.
b)	For applicants who obtained the academic qualification (1st or 2nd level) in Italy:  Fill in the section "STUDI COMPIUTI" in the Apply platform with the complete study plan.	In the event that applicants have <b>two (or more) Master's degrees (2<sup>nd</sup> level)</b> , they must state in their application form which qualification they want to use to compete for admission to the PhD programme. The other degrees must be attached under the section "Ogni altro documento" (i.e., "Any Other Document") as provided for by letter I) of this table.









### For applicants who obtained the academic qualification (1st or 2nd level) abroad:

- First-level degree diploma (EQF level 6) corresponding to the Italian Bachelor's degree (Laurea). The degree must be awarded by an accredited/recognized foreign university and allow access to second-cycle programmes (EQF level 7).
- Certificate with all the exams taken in the Bachelor's degree programme (front and back scan) or a document issued by the University including all the exams taken.
- Second-level degree diploma (EQF level 7), corresponding to the Italian Master's degree (Laurea Magistrale). The degree awarded must be by accredited/recognized foreign university and allow access to third-cycle programmes (EQF level 8). If the official diploma is not available yet, a provisional one can be accepted. Otherwise, it is necessary an official document the specifies the expected date of graduation.
- Certificate with all the exams taken in the Master's degree programme (front and back scan). If at the final year of programme, a certificate of the exams taken - as updated as possible - with the average of final or current grades;
- Diploma Supplement, Declaration of value or Statement of Comparability issued by the Italian ENIC-NARIC - CIMEA, if available.

The documents must be:

- On headed paper with the stamp of the issuing institution and the signature of administrator in charae electronically signed, they can only be accepted if verifiable online via QR code or verification link);
- in Italian, English, French or Spanish by the issuing University. In case of any other language than those mentioned above, applicants are required to attach both the original version of the document and a translation, with the stamp and original signature of an official translator, in Italian or English in the same file.

Candidates who obtained a 1st or 2nd level qualification at a non-European University are required to include a short explanation on the evaluation system (minimum and maximum grade for passing each exam, final grade, medium average) and the credit system to which it refers. In the event that this information is not present in the document, it is necessary to provide and attach an official statement issued by University that includes the information.

In the event that applicants have two (or more) Master's degrees (2<sup>nd</sup> level), they must state in their application form which qualification they want to use to compete for admission to the PhD programme.

The other degrees must be attached under the section "Ogni altro documento" (i.e., "Any Other Document") as provided for by letter I) of this table.

English language certificate (level B2) as indicated in art. 6, par. 1, letter b), if already obtained.

For cases of exemption, as provided by art. 6, par. 1, letter b), an official statement issued by the University attesting that the academic learning path was held entirely in English.

With score, date and place of examination, if already obtained.

d)	Abstract of Master's thesis	The document must be written in English and uploaded in PDF format.  A short but complete abstract of the Master's thesis project which must include the overall objectives, the methodologies, the major results and above all the individual contribution. The format is free and can include tables, graphs and/or images.  Minimum 3000 characters, maximum 6000 characters.
e)	Short statement of Purpose (SoP) on the applicant's research interests and motivations for undertaking a PhD programme	The statement of purpose must be written in English – maximum 8000 characters.  Applicants must highlight their scientific background in the topics that will studied during the PhD programme they are applying for. Applicants need to emphasize their ability to engage with one or more research topics and must clarify their motivations, objectives, aspirations and personal inclination for the research topics. Applicants must also highlight their capacity to develop a research project and declare its assumptions, objectives and methodology.  Applicants who compete for more than one PhD programmes are allowed to submit a separate statement of purpose for each programme they are applying for.
f)	Name and e-mail address of two referees who can be contacted by the Admissions Committee to get useful information for the evaluation of the application	Preferably one faculty member from Politecnico di Torino and one faculty member on the staff of another university (Italian or international university).  For PhD programmes in cooperation with other institutions, the PoliTo faculty member can be replaced by a faculty member pertaining to the partner institution.

Applications for the selection process must include all the above-mentioned attachments, of which they are integral part, and must be written in the form of a lawful self-declaration (in accordance with art. 46 and 46 of DPR no. 445/2000 and subsequent amendments). The application must include all the necessary information for the evaluation of the academic qualification and the verification of its truthfulness. Failure to include even a single element entails that the qualification will not be evaluated.

Applicants are <u>not</u> allowed to upload any additional document **after submitting their application**. For this reason, for applicants admitted to the selection process "with condition", Politecnico di Torino will consider the average grade of the exams taken during the Master's degree programme instead of the final grade.

Politecnico di Torino will not take into consideration any declaration, qualification, publication or request to modify submitted documents after the closing date of this Call. Politecnico di Torino will evaluate exclusively the qualifications already obtained by the applicant before the closing date of the Call and submitted in accordance with the instructions provided in this article.

- 4. Applicants are required to pay a non-refundable fee (€ 30.00) for each application they intend to submit. The payment must take place at the end of the online application process with the following payment methods:
  - a) credit cards (or other payment methods available on the PagoPA platform) generating an **immediate payment**;
  - b) pre-printed notice of payment (MAV on the PagoPA platform), generating a **deferred payment**.

Applicants who pay using the method illustrated under letter b) must pay before the deadlines referred in art. 7, par. 1.

The application process is finalized and valid only after the payment of the above-mentioned fee. Applications cannot be modified after the payment takes place.

- 5. In their application forms, applicants must declare under their own responsibility:
  - that they are aware that the originality of their publications and papers presented for admission to the programme or produced during a PhD programme at Politecnico di Torino may be checked with an anti-plagiarism software;
  - if they are currently working on the date of application submission and if they will be working on 1st November 2025 (for applicants competing for the first session) and on 1st March 2026 (for applicants competing for the second session).

#### Art. 8 – Candidates with a certification of invalidity, disability, or a diagnosis of Specific Learning **Disabilities**

- 1. Applicants who require special arrangements for the interview must submit appropriate documentation within 15 working days from the date of the exam (attaching it in .pdf format in the Apply procedure). Specifically, please note that:
  - a) those holding a disability certificate or an invalidity certificate pursuant to Article 16 of Law no. 104/92 must submit appropriate certification issued by the competent medical commission, proving the type of recognized disability and/or degree of invalidity;
  - b) those diagnosed with specific learning disabilities, pursuant to Law no. 170/2010, must submit appropriate certification issued no more than three years prior (at the time of enrolment in the bachelor's degree program) by National Health Service (SSN) structures or specialists and accredited institutions. Certifications issued upon reaching the age of 18 are also valid;
  - c) candidates holding a disability or SLD certificate and residing in foreign countries must submit certification proving their disability or SLD status issued in their country of residence. The documents must be official, bearing the stamp of the issuing institution and the signature of the designated official, and must be written in one of the following languages: Italian, English, French, or Spanish. If the official documents are in other languages, both the original language version and the official Italian or English translation must be included in the same file. The University authorities responsible for reviewing these certifications will verify that the foreign documentation confirms a disability or specific learning disorder condition recognized under Italian law.
- 2. The organization of the interviews outlined in this Call will take into account such needs in compliance with current regulations, following the verification of certifications by the Special Needs Unit of Politecnico di Torino, which will validate their suitability.
- 3. The following compensatory measures are provided for the interview:
  - a) additional time (30% extra, which may be increased to 50% in cases of disability if explicitly requested);
  - b) use of a calculator;









- c) possible assistance from a sign language interpreter, which must be requested within 15 working days from the interview date, along with the submission of the aforementioned documentation.

#### Art. 9 – Assessment of the admission requirements for the selection process

- 2. Politecnico di Torino reserves itself the right to:

#### Art. 10 – Assessment criteria

Applicants will be assessed by a **specific Admissions Committee for each PhD programme**, appointed by the Rector and staffed by minimum three members chosen from among tenured faculty members and permanent researchers or other professionals with competencies in the specific research field for PhD programmes organized in cooperation with other institutions (see list in art. 1).

The Admissions Committee is free to decide to conduct the interview in a specific way that will be illustrated in the interview timetable (see par. 9).

6. Applicants who cannot attend the oral interview in person at Politecnico di Torino can ask the Admissions Committee to have a remote interview (videoconference) in accordance with the terms which will be specified when the interview timetable is published. In this case, applicants must specify their contact details which are going to be used by the Committee for the video call. They must also ensure that they will make use of a webcam to be identified.

## Art. 11 – Ranking lists

1. At the end of the evaluation process, each Admissions Committee drafts the merit ranking list of all eligible applicants for the PhD programme based on the score obtained by each examined candidate. In case of equal merit, the following criteria prevail for the allocation of positions.

For the PhD Programmes in "Design and Technology. People, Environment, Systems", Energetics", "Physics", "Aerospace Engineering", "Electrical, Electronic and Communications Engineering", "Computer and Control Engineering", "Mechanical Engineering" and "Mathematical Sciences", the female gender prevails, followed by the younger age.









For the PhD Programmes in "Architecture. History and Project", "Bioengineering and Medical-Surgical Sciences", "Chemical Engineering", "Civil and Environmental Engineering", "Management and Production Engineering", "Patrimonio Architettonico / Architectural Heritage", "Materials Science and Technology" and "Urban and Regional Development" the younger age prevails.

- 2. Only the applicants who score 60/100 points or above will be included in the ranking list.
- 3. A conditional offer of admission will be made to eligible applicants who have not earned their Master's degree yet (see art. 6 par. 1 letter a), and/or have not submitted their English language certificate yet (see art. 6, par. 1 letter b).
- 4. The Admissions Committee offers the PhD scholarships/positions in apprenticeship format to the applicants taking into consideration the number of scholarships/positions available, the applicants' position on the ranking list, their cultural-scientific interests and eligibility to receive a scholarship with predefined research topic based on:
  - a. the position of the applicant on the ranking list;
  - b. the number of fully-funded positions with predefined research topic, based on the order of the ranking list and on the assessment of the educational background of the applicant carried out by the Admissions Committee, until all places are full.
    If the Admissions Committee does not offer some PhD scholarships/positions in apprenticeship format with predefined research topic to any applicant, or in the event of subsequent withdrawal of a PhD candidate from the programme, the number of PhD positions provided for in this Call will be reduced.

#### Art. 12 – How to accept an offer of admission and a PhD scholarship

1. Applicants who are admitted to a PhD programme in the first session (including applicants admitted "under condition") are required to accept their offer of admission online and pay a fee (161,00 euros). This amount will be deducted from the tuition fees when the applicant enrols in the programme in the event that the amount is increased after the publication of this Call (see art. 15). This amount will not be refunded if the applicant eventually decides not to enrol in the programme (see art. 13). Failure to pay the above-mentioned fee entails permanent exclusion form the admission process. The deadlines for paying the fee are the following:

#### Art. 16 – Rights and responsibilities of PhD candidates

- 1. Attending a PhD programme requires exclusive and full-time commitment. PhD candidates are required to attend classes full-time and conduct their study and research activities in their Department and in compliance with the Call for applications, the Regulations for PhD programmes and the terms established by the Academic Board of the programme.
- 2. Civil servants admitted to a PhD programme are placed on unpaid special leave for study purposes from the beginning of the PhD programme and for its entire duration, if this is compatible with the needs of the employer (Public Administration). During this period, they may receive a scholarship. In the event that civil servants are admitted to a PhD programme without any scholarship or if they renounce it they are placed on special leave but keep their salary and social security contributions from the employer. In this case, if they resign from office within two years from the date of PhD degree conferral, they must refund their salaries (received during the entire duration of the PhD programme) to their employer.

Civil servants who already hold a PhD degree or have been enrolled in a PhD programme with special leave from work for at least one academic year do not have the right to be placed on paid or unpaid special leave.

- 3. For company employees who are awarded a position without scholarship, pursuant to Article 17, par. 5 of the current PhD Regulations, the activation of the specific position requires the signing of a funded agreement between the company and the University.
- 4. Non-EU citizens are required to comply with the norms on entry visa and residence permit.
- 5. Possible further responsibilities are specified in the thematic sheet of each PhD programme.

#### Art. 17 - Causes of exclusion

- 1. In addition to exclusion due to lack of requirements and/or incomplete or incorrect documentation, as outlined in articles 6 and 7, the following cases also apply:

#### **Selection process**
