ISEE

ISEE stands for Equivalent Economic Situation Indicator.

It is a document that indicates a family's economic and property situation. It can be requested online through the INPS website or by contacting an authorized intermediary (CAF or accountant).

There are many types of ISEE:

- Universitario
- Parificato
- Corrente

This tutorial applies to the Tuition Fee Regulation of the Politecnico di Torino, exclusively for students enrolling for the first time in the academic year 2025/2026.

ISEE UNIVERSITARIO

The **ISEE Universitario** is used to request special benefits related to the right to university education. It is the only ISEE type accepted to apply for tuition fee reduction. To obtain your ISEE Universitario, you need to submit your DSU (*Dichiarazione Sostitutiva Unica*) to an authorized ISEE issuing centre (such as CAF, INPS, etc.).

The **DSU** (*Dichiarazione Sostitutiva Unica*) is a document with information about the number of your family members and their income and assets. It is necessary to calculate your ISEE.

Students financially independent for ISEE purposes

referred to in article 8 of Ministerial Decree no. 159 dated 5th December 2013, Ministerial Decree No. 1320/2021, and MUR Circular No. 13676 of 11 May 2022

You class as independent student for ISEE purposes if, for at least the last 2 years prior to the DSU submission date:

- you have been residing in a housing unit different from that of your family of origin and **not owned by any member of your family**

AND

- your employment income or tax-assimilated income has been **equal to or higher than €9,000 per year in both of the two previous years.**

If you have **met both of the above-mentioned requirements** for at least 2 years as of the DSU submission date used to apply for tuition fee reduction, before submitting your application you must open a ticket with the topic “Tuition Fees” through your personal page of the Teaching Portal, in order to evaluate your specific situation.

● **PLEASE MIND!**

If you do not meet these requirements, you must request an ISEE that includes all members of your original family household.

ISEE CORRENTE

referred to in article 9 of Ministerial Decree no. 159 dated 5th December 2013

ISEE Corrente is used to describe the most recent financial condition and to analyse events which may affect one's financial situation, like: loss of employment contract, interruption of social security, welfare or compensation benefits, a change in household income higher than 25%, or a change in household assets greater than 20%.

In order to check if you meet these requirements and to apply for ISEE Corrente, you need to contact an authorized ISEE issuing centre (such as CAF, INPS, etc.). The deadline for providing your ISEE Corrente is **10/12/2025**.

● PLEASE NOTE!

Italian citizenship students must open a ticket with the subject "Fees" from their personal page on the Didactic Portal to request the registration of the Equivalent ISEE.

If your family members residing in Italy have both income and assets in Italy AND abroad, you need to provide an ISEE Parificato AND an ISEE Ordinario.
