FOR STUDENTS ENROLLED FOR THE FIRST TIME BEFORE THE A.Y. 2025/2026

Issued by Rector's Decree No. 723/2025 dated 27/06/2025

The English translation of this document is provided as a support to the student community and has no legal effects. The Italian version shall constitute the sole authentic text and will be referred to for any legal matters.

SECTION 1 – Introduction

Article 1 – General Provisions

- 1. This Regulation, adopted in accordance with Article 17 of the Student Regulations, sets out the rules regarding:
 - a. the amount of Student fees (hereafter referred to as "fees");
 - b. the criteria for obtaining exemptions, reductions, and other benefits;
 - c. payment and refund procedures and deadlines, as well as steps the University may take in case of non-payment;
 - d. the system of checks and penalties applied to self-declared financial data used to request fee reductions.
- 2. This Regulation applies to Students enrolled in the 2025/2026 a.y. in the following programmes:
 - a) Bachelor's and Master's degree programmes under Ministerial Decrees 509/99 and 270/04, if first enrolled before 2025/2026;
 - b) Master's degree programmes under Ministerial Decree 270/04, if first enrolled before 2025/2026;
 - c) Degree or University Diploma programmes under the system prior to Ministerial Decree 509/99;
 - d) PhD programmes and Specialisation Schools, to the extent compatible with the specific rules for such programmes.

The provisions in this Regulation apply:

- o until the 2027/2028 a.y.for the programmes listed under points a) and c);
- o until the 2026/2027 a.y.for those under point b).
- 3. The annual Student fee is made up of the following components:

Fees managed by the University:

- Yearly comprehensive fee, required under Article 1, paragraph 252 of Law No. 232 of 11
 December 2016. This is the amount Students must pay to cover the costs of teaching, research, and administrative services. It varies depending on:
 - i. the work load selected at enrolment (full-time or part-time);
 - ii. the contribution level assigned after any approved fee reduction;
 - iii. the number of years of enrolment;
 - iv. the number of credits (CFU) obtained; v. any exemptions granted.
- Fees not managed by the University:
- i. Regional fee for Student support (EDISU): €140 (*), collected by the University on behalf of EDISU.
- o ii. Stamp duty on enrolment: €16 (*).
- o iii. Accident insurance premium: €5 ().
 - (*) These amounts may change based on decisions made each year by the responsible authorities.
- 4. The annual fee is divided into three instalments, with deadlines and payment methods outlined in Articles 20 and 21.
- 5. By enrolling in the academic year, Students agree to pay the full amount of the fees by the set deadlines. This applies even if they do not use the University's teaching, research, or administrative

- services, do not progress in their studies, or their Student record is temporarily frozen. The only exceptions are Students who withdraw from the University or transfer to another institution (see Articles 28 and 29).

- 7. Students are responsible for being familiar with and following the rules outlined in this Regulation.
- 8. Information about the amount of fees due is available in each Student's personal area on the Teaching Portal under: Online Services Tuition fees and payments Pay your tuition fees.

SECTION 2 – Tuition Fees

Article 2 – Fees for EU Students Enrolled in a Bachelor's or in a Master's degree programme (under Ministerial Decrees 509/99 and 270/04) or in a Degree/University Diploma programme under the pre-509/99 system

1. The maximum tuition fees for EU Students are listed in the following table:

- 2. Students can **apply for a fee reduction** according to the procedures and deadlines set out in Articles 17, 18, and 19.
- 3. The fee amount, once determined, is divided into three instalments:

o First instalment: €161

o **Second instalment**: 50% of the all-inclusive fee

Third instalment: 50% of the all-inclusive fee

Payment procedures and deadlines are outlined in Articles 20 and 21.

4. All fee details are provided in **Annex 4** of this Regulation.

Article 3 – Fees for Non-EU Students Enrolled in Bachelor's or Master's degree programme or in Programmes under the Pre-509/99 System

For non-EU Students not residing in Italy, tuition fees are calculated using a flat range system:

 a. The minimum and maximum fees, based on the Student's country of origin, are listed in Annex 2 ("Tuition fees under the flat rate system").

- b. Students in this system can request a **fee reduction** by following the same procedure and deadlines as in Articles 17, 18, and 19. However, the final fee **cannot be lower** than the minimum amount set for their country.
- Non-EU Students residing in Italy must refer to the fees outlined in Article 2.
 These Students must declare their residence through the Online Student Services area on the Teaching Portal:
 - Online Services View your data and change your address Personal details Current address.
- 3. Residence must be officially registered with the local Municipality (*Anagrafe* Office) and declared no later than 31 December 2025.
 - Residence will be **verified**. If the verification fails, the Student will be required to pay the **maximum fee** for their country of origin according to the flat range system in point 1.
- 4. These fee provisions do not apply to Students eligible for fee waivers under Article 12.

Article 4 - Fees for PhD Students

- 1. Under national law, PhD Students—whether or not they receive a scholarship—are only required to pay the **fees not managed by the University** (see Article 1, section 3, point b).
- 2. Additional **exemption rules** are listed in **Article 12**.
- 3. The required payments must be made **when enrolling** in the following academic years, regardless of the actual start date of the PhD programme.
- 4. These non-University fees (as listed in Article 1, section 3, point b) are also due if the PhD Student has been granted an **extension** into the next academic year.
- 5. Additional charges for administrative actions carried out after deadlines are detailed in Article 36.

SECTION 3 – Special Cases

Article 5 – Fees for Students Enrolled in Two Programmes at the Same Time

1. Students who, in the 2025/2026 academic year, are enrolled in two higher education courses at the same time – with at least one of them at Politecnico di Torino – must pay the tuition fees as listed below:

^{*} If the Student's contribution has increased by 15% or 25% due to extended enrolment beyond the normal duration, that increase is **not** included when calculating the 50%.

For "end-of-career" Students (Article 6), the 50% is based on their final contribution level. Exemptions from the regional fee (Article 1) may change according to regional laws.

2. For any cases not covered above, Students must pay the **full Yearly comprehensive fee** due, with no further reductions.

Article 6 - End-of-Career Students

- 1. The "end-of-career" status applies to Students who meet all the following criteria:
 - o Completed all required exams by the final session of the 2024/2025 academic year.
 - o Included their internship in their 2024/2025 APSP and completed it by 31 December 2025.
 - o Included their thesis in their 2024/2025 APSP.
 - In 2025/2026, do **not** enrol both in a Bachelor's and later in a Master's degree programme.
- 2. Students satisfying these conditions must pay a **fixed fee of €361**, regardless of full-time or part-time status.
- 3. They may still apply for a fee reduction (see Articles 17,18,19 of this document); if the resulting total fee is less than €361, the lower amount will apply.
 - Students awaiting registration of their last exams must still enrol for 2025/2026 before the dead-lines published in the Student Guide.
 - Once these exams are registered, if they qualify for end-of-career status, they are required to submit a "Tuition Fees" support ticket via the Teaching Portal to request an update of their fee status.

Article 7 – Students Enrolling in a Bachelor's and, after graduation, in a Master's degree programme in the a.y. 2025/2026

- 1. Students who enrol in a **Bachelor's degree** and then, after graduation, enrol in a **Master's degree** in the same a.y. must pay tuition fees **only for the Bachelor's degree**.
- 2. At the time of Master's enrolment, they are required to pay **only the €16 stamp duty** for the second enrolment.
- 3. The **full-time** or **part-time** status chosen at Bachelor's degree enrolment remains for the Master's degree enrolment.
 - If a Student wishes to switch from part-time to full-time at Master's enrolment, they must pay any difference calculated under the 2025/2026 Fee Regulation for Students enrolled at Politecnico for the first time.
- 4. Fee reduction must be requested as described in Section 5 and **before** registering for the final exam. Requests submitted later will not be accepted.

Article 8 – Students Whose yearly comprehensive fee is paid by Third Parties

 If a third party fully or partially covers the all-inclusive tuition fee, the Student is still responsible for paying the non-University fees (Article 1).
 Cases are summarised as:

Article 9 - Mobility Participants (Incoming or Outgoing)

1. Incoming and outgoing students taking part in mobility programmes must pay the tuition fees shown in the table below.

Article 10 – Alta Scuola Politecnica (ASP) Students

- 1. Students in the ASP programme do not have to pay general tuition fees for the two academic years of the programme.
- 2. If a student loses their ASP status:
- a. They must pay the full tuition fees for all years when the exemption was applied, including past years. However, to avoid paying the highest fee amount, ASP students can still apply for a fee reduction by following the process and deadlines described in Part V.
- b. The required fees must be paid within 30 days from the notification email, which will be sent to the institutional email account.
 - 3. Students who, in the academic year 2025/2026, enrol in a Bachelor's degree programme at Politecnico di Torino and then, after graduating, enrol in a Master's degree programme and join the ASP programme, will receive a refund of the part of tuition fees due to the university after enrolling in the Master's degree programme.

SECTION 4 – CASES OF EXEMPTION

Article 11 - No-Tax Area

- According to Law no. 232 of 11/12/2016, Ministerial Decree no. 1014 of 03/08/2021, and the Resolution no. 86 of 30/03/2017 of the Politecnico di Torino Board of Directors, a no-tax area is established. For the a.y.2025/2026, Students enrolled within the normal duration of their study programme plus one additional year are fully exempted from university tuition fees if their ISEE is up to €25,500.
 - This exemption does **not** apply to non-University fees (see Article 1).
- 2. A **partial exemption** applies to Students who meet one of the following conditions:
- a. Enrolled within the normal duration + one year (in 2025/2026), ISEE between €25,500.01 and €30,500
- b. Enrolled beyond the normal duration + one year (in 2025/2026), ISEE less than €30,500
 - 3. Exemptions (full or partial) are granted to Students enrolled in a Bachelor's or Master's degree programme (full-time or part-time), who meet **all** of the following conditions:
 - Income requirements: ISEE only (ISPE is not considered);
 - Merit requirements: minimum number of credits (CFUs) earned;
 - Registration limits: based on number of years enrolled (as calculated in Article 1).

Article 12 - Students Fully Exempt from Tuition Fees

Students who are exempt from paying tuition (by law or by decision of the Politecnico) must still
pay non-university fees (see Article 1). The exemption types and corresponding fees are listed below.

Article 13 - Edisu Scholarship Holders

- Edisu Piemonte is the Regional Authority for the Right to University Education. It offers scholarships and other services to support capable and deserving Students.
 More info: https://www.edisu.piemonte.it
- 2. Students applying for the Edisu scholarship with complete valid financial documentation do not need to apply for a fee reduction to the Politecnico. Edisu will forward ISEE data to the university.
- If excluded from final Edisu rankings due to documentation issues, Students may request a fee reduction via the Politecnico (see Part V).
- Students who applied for the Edisu scholarship but do not want the Politecnico fee reduction must submit a "Tuition Fees" support ticket by the deadline in Article 19.
- 3. Students enrolled in two institutions (Article 5), and who apply for an Edisu scholarship outside Piedmont, must still apply for the Politecnico fee reduction (see Section 5).
- 4. Students eligible for or awarded an Edisu scholarship are exempt from both the yearly comprehensive fee and the regional fee.
 - Students in later years or PhD/Specialisation Schools can request reimbursement of the regional fee (see Article 23) once the final Edisu rankings are published.
- 5. Students who were eligible/awarded in the previous academic year must declare their intent for 2025/2026 when enrolling:
- If they apply or plan to apply for the scholarship: pay only stamp duty and accident insurance. Final Edisu ranking confirms eligibility.
- If they do not apply, they may request a fee reduction via the procedure in Section 5.
- 6. Revocation or Withdrawal from the Edisu Scholarship:
- a. The Student will be charged the tuition fee according to their contribution level. Payment is due within 30 days of notification.
- b. For non-EU Students not residing in Italy, first enrolled before 2025/2026, and whose scholarship is revoked for not meeting merit requirements, fees will be recalculated using the flat rate system (Article 3). However, if the Student earns at least 10 CFUs by 10/08/2026, they will be charged based on Article 2.
 - 7. If a Student has outstanding payments with Edisu, the university may block their academic records at Edisu's request.

Article 14 - Exemption for Students with Siblings Also Enrolled at Politecnico

- 1. If **two** or more siblings are enrolled at Politecnico di Torino in the same academic year, one sibling is granted a **10%** exemption on the university's share of the tuition.
- 2. The discount applies to the sibling with the most recent first enrolment at Politecnico di Torino.

SECTION 5 – FEE REDUCTION

Article 15 - Fee Reduction - Introduction

- 1. Fee reductions are available only to Students enrolled in first and second cycle degree programmes who apply according to the procedures and deadlines in Articles 17, 18, and 19. The application must be submitted every academic year.
- 2. Applications for fee reduction must be made online only, either at the time of enrolment (Article 17) or afterwards (Article 18).
- 3. To apply for a fee reduction, Students must provide one of the following certificates: a. *ISEE* (Equivalent Economic Situation Indicator) for university support benefits, calculated in the 2025 calendar year.
 - b. *ISEE Parificato*, calculated in 2025 exclusively by *C.A.A.F. offices* partnered with Politecnico di Torino for the a.y.2025/2026, between 01/01/2025 and 31/12/2025. A list of these offices is available here: <a href="https://www.polito.it/didattica/servizi-e-vita-al-politecnico/diritto-allo-studio-e-contribuzione-Studentesca/contribuzione-Studentesc
 - c. Current ISEE.
- 4. Fee reductions apply only if the following thresholds are not exceeded at the same time:
 - a. ISEE Universitario/ISEEU/ISEEUP ≤ €85,500
 - b. ISPE/ISPEU/ISPEUP (Equivalent Patrimonial Situation Indicator): ≤ €210,000
 The ISPE/ISPEU/ISPEUP is calculated by dividing the Patrimonial Situation Indicator (ISP) by the equivalence scale (SE, Scala di Equivalenza). This is not considered for Students eligible for the notax area (Article 11).
- 5. Once submitted, the application is valid for the entire 2025/2026 a.y.and can only be changed if the ISEE certificate has errors or missing information. In that case, Students must request an update by submitting a ticket with the subject "Tuition fees" by the deadline in Article 19.
- 6. Any problems should be reported by opening a ticket with the subject "Tuition fees" via the Student's personal page on the Teaching Portal.

Article 16 - ISEE with Omissions or Discrepancies

- 1. If a Student applies for a reduction with an ISEE certificate containing omissions or discrepancies:
 - a. The certificate is accepted provisionally and the Student is assigned a provisional fee level;
 - b. The Student is notified by email to their institutional account and must, within 30 days:
 - i. Submit a corrected ISEE without omissions or discrepancies. No penalties will apply if the fee level changes;
 - ii. Submit documents to fix formal errors or prove the certificate's correctness by opening a ticket with the subject "Tuition fees ". However, formal corrections don't exclude further checks on the certificate's substance (see Section 7).
- 2. Students who do not submit the required documents within the deadline will be assigned the highest fee level permanently.

Article 17 - Applying for Reduction at Enrolment

- 1. Fee reduction can be requested during enrolment as follows:
 - a. Students using University or Current ISEE give consent to check INPS database to retrieve ISEE data;
 - b. Students using Parificato ISEE confirm the economic data from the previous academic year.
- 2. If consent is not given or data cannot be confirmed, Students can still request reduction later (Article 18).

- 4. A confirmation email will be sent to the institutional account after completing the request.

Article 18 – Applying for Reduction After Enrolment

- 1. Students who didn't apply at enrolment can apply later by completing the online procedure in their personal page under: Tuition fees and payments Apply for tuition fee reduction.
 - a. For University or Current ISEE, Students must enter the date of DSU submission if ISEE is not in the INPS database. The request is complete only after receiving an email confirming the final economic level for 2025/2026. If this email is not received within 5 days, the Student must contact the Student Access and Right to Study office.
 - b. Students using ISEE Parificato confirm data from the previous academic year.

- 3. A confirmation email will be sent after completing the request.

Article 19 – Deadline to Apply for Fee Reduction

- 1. The deadline to apply is 10 December 2025.
- 2. After this date, it will no longer be possible to apply for reduction and Students must pay the maximum comprehensive fee.

SECTION 6 – PAYMENT OF FEES, REFUNDS, AND DEBT COLLECTION

Article 20 – Payment Methods for Fees and Other Amounts Due

- 1. All payments must be made through the PagoPA platform, using the procedure available in the personal area of the Teaching Portal, under Online Services Tuition fees and payments Pay your tuition fees.
- 2. When paying, you can choose one of the following payment types:
 - a. Immediate payment: by credit card, online bank transfer, or other available methods. PagoPA may not allow credit card payments over €1,000 in one go; if so, you need to make multiple payments, manually entering the amount to pay each time until the total is covered.
 - b. **Deferred payment:** by creating a payment notice (MAV), which can be paid at bank counters or via online banking. The payment is automatically recorded within 24-48 hours of payment. Please note:
 - i. For any operation that requires simultaneous payment (e.g., enrolment, final exam registration), you must self-certify the payment date by returning to the enrolment/registration procedure and clicking the "Register MAV" button;
 - ii. MAV payments made after 5 pm may not be processed the same day. Check with your bank for payment processing times. Late payments may be processed after the deadline, and the University will apply penalties accordingly.
- 3. Those eligible for the "Electronic Card for the professional development and training of permanent school teachers" (known as Carta docente), under Law 107/2016 (Law Buona Scuola), can use the card (max value €500) to pay part of their Student fees. To do this, they must send the QR code linked to the card by opening a ticket from their personal portal page, selecting subject "Tuition fees".

Article 21 – Deadlines for Payment of Fees and Other Amounts Due

1. Fees are divided into three annual instalments, to be paid by the following deadlines:

a. 1st instalment: at enrolmentb. 2nd instalment: 19/12/2025c. 3rd instalment: 15/04/2026

Other amounts due must be paid by 31/05/2026 or by the deadline for final exam enrolment if earlier.

Article 22 - Career Block for Non-Payment or Late Payment of Fees or Other Amounts Due

- If instalments or other amounts are not fully paid by the deadlines or before final exam enrolment (if earlier), the Student's career will be blocked, and they will not be able to carry out any career actions (exam bookings, withdrawing from studies, certificates, self-certifications, etc.). Any exam bookings already made will be cancelled. The career block will only be lifted after payment of the owed amounts.
- 2. Lifting the career block due to late payment of fees costs €10.
- 3. Notifications about career block and unblock fees will be sent via email to the institutional account.
- 4. If a Student withdraws from studies, unpaid fees remain a debt and must still be paid.

Article 23 – Refund Request Procedures

- 1. Refunds of credit amounts can be requested by clicking the "Request Refund" button on the personal page of the Didactic Portal, under Online Services Tuition fees and payments Pay your tuition fees.
- 2. For Students who have graduated and do not continue studying at the University, refunds will be made automatically at the end of the academic year.
- 3. Refunds will be made only if the Student specifies the payment method using the procedure on the personal page of the Didactic Portal, under Online Services Tuition fees and payments Pay your tuition fees. The only payment method allowed is bank transfer to a bank or postal account. The IBAN must belong to the Student, either as sole holder or co-holder.
- 4. **Debt Collection:** By enrolling for the academic year, Students commit to paying the full fees within the prescribed deadlines, regardless of the actual use of teaching, scientific or administrative services, career actions, career blocks, or payment in instalments (Article 1). If there are unpaid debts by the deadlines in Article 21, the University will take all necessary actions to recover the debt.
- 5. Debt recovery notices will be sent via the Digital Notifications Service (SEND) of the PagoPA platform
- 6. Debts under €15 will not be pursued.

SECTION 7 – BENEFITS

Article 24 - Financial Merit Benefits

- 1. Students enrolled in a Bachelor's or in a Master's degree programme who achieve high academic results, based on the score described in point 3, will receive a financial merit benefit of €200.
- 2. The benefit can be given in one of two ways:
 - a. A reduction of the overall tuition fee (excluding fees not managed by the University) if the total fee is €200 or more.
 - b. A scholarship if the total fee is less than €200 and the Student has chosen a payment method as explained in Article 23.
 - The benefit will be calculated based on the final or provisional fee level. If provisional, adjustments will be made with the second payment after 13/03/2026.
 - Even if the benefit covers the full first payment, the stamp duty still needs to be paid.
- 3. The score is calculated on exams passed and recorded in the 12 months before 10/08/2025, as follows:
 - a. For each exam, multiply the credits (CFU) by the grade. For exams without a numeric grade, use the weighted average of graded exams.
 - b. Add all these results together.

The following exams are excluded from the score:

- Exams to make up for missing programme requirements;
- Exams from previous closed study careers, even if recognised;
- Exams not needed to complete the degree.
- 4. The minimum score needed to get the benefit is:
 - 1,210 points for Students who first enrolled in 2024/2025;
 - 1,455 points for Students enrolled before 2024/2025.
- 5. The benefit is only given to Students who enrol full-time in 2025/2026.
- 6. The benefit can be awarded a maximum of:
 - a. 3 times for Bachelor's Students (the third only if enrolling in a Master's degree programme at Politecnico di Torino);
 - b. 1 time for Master's degree Students.

- 7. The University will automatically apply the benefit; Students do not need to apply.
- 8. Special cases:
 - a. If a Student withdraws from studies or transfers to another University in 2025/2026, the benefit cannot be more than the fee they actually paid.
 - b. If a Student enrols in both a Bachelor's and a Master's course in 2025/2026:
 - i. The benefit will be applied after enrolling in the Master's;
 - ii. The benefit will be cancelled if they guit before 30/06/2026.
 - c. Students enrolled in two degree programmes at the same time will only get the benefit for one degree programme.
- 9. The benefit is NOT given to Students who:
 - a. Enrol part-time;
 - b. Already have a degree at the same level;
 - c. Are in special study programmes with special financial support;
 - d. Receive scholarships or financial support from the University that can't be combined with this benefit:
 - e. Are under disciplinary action by the University.
- 10. For Students on outgoing mobility programmes or international programmes:
 - a. If the study abroad ends before 10/08/2025, all validated exams are included in the merit score;
 - b. If the study abroad ends after 10/08/2025, academic merit is calculated proportionally based on the actual period of mobility. The number of ECTS credits is calculated as follows:
 - i. The total number of validated ECTS credits is divided by the total number of days of the entire mobility period;
 - ii. The result is then multiplied by the number of days from the start of the mobility period up to 10/08/2025.
- 11. For the purpose of assigning the benefits referred to in this article, the ECTS credits calculated as described in paragraph 1.b are given a grade equal to the weighted average of the validated exam marks for the entire mobility period (For these Students, the credits counted proportionally are given the weighted average grade of all validated exams).

Article 25 – Benefits for 'Percorso Intraprendenti' Programme

- 1. Students in their 2nd and 3rd year of this programme may get a fee reduction of the yearly comprehensive fee (not a reduction of the fees not managed by the University) or scholarship depending on available funds.

Article 27 - Transfer to another University

- 1. Students who request a transfer to another university on or before 19/12/2025 are not required to enrol for the 2025/2026 academic year, whereas those who submit their request from 20/12/2025 onwards must enrol for the 2025/2026 academic year.
- 2. Students who have enrolled for the 2025/2026 academic year and request a transfer to another university before the deadline for payment of the second instalment of tuition fees (see Article 21) may apply for cancellation of their enrolment. In this case, a refund will be issued for the fees paid for the 2025/2026 academic year, except for the €16 stamp duty.
- 3. Students who request a transfer to another university on or before 14/04/2025 are not required to pay the third instalment (see Articles 1 and 21).
- 4. The request of carries a fee of €66, which includes €16 stamp duty and €50 in administrative fees.

Article 28 – Withdrawal from Studies

- 1. Students who enrol in the 2025/2026 academic year and request withdrawal from studies before the deadline for payment of either the second or third instalment of tuition fees (see Article 21) are not required to pay the instalment due.
- 2. Students intending to withdraw before the second instalment deadline (see Article 21), but who have not yet been assigned a final tuition bracket for the 2025/2026 academic year, must pay the first instalment at the maximum contribution level unless they submit a request for a reduction before submitting the withdrawal request.

Article 29 - Interruption and Resumption of Studies

- 1. Students resuming their studies after one or more years of non-enrolment (interruption) must:
 - a. pay any outstanding fees related to the last academic year in which they were enrolled;
 - b. pay a reinstatement fee of €100 for each academic year of non-enrolment;
 - c. pay the tuition fees for the current academic year, according to the methods and deadlines indicated in Articles 20 and 21.
- 2. Students who request to resume their studies but do not complete enrolment by 30/06/2026 must pay a €100 administrative fee for the incomplete procedure. In addition, they will not receive recognition for the academic years for which reinstatement was requested.
- 3. If a reassessment of the previous academic record is required, a fee of €150 must be paid. This amount will be deducted from the tuition fees in the event of subsequent enrolment, otherwise it will not be refunded.

Article 30 – Suspension and Resumption of Studies

- 1. Students requesting a suspension of studies must have paid all tuition fees due for the last academic year in which they were enrolled.
- 2. Suspension during the current academic year is allowed only in cases of serious personal or family reasons, pregnancy, birth/adoption, or serious and prolonged illness.

 Students who request a suspension during the 2025/2026 academic year, before the deadline for the second or third instalment, are not required to pay the corresponding instalment.

Article 31 – Internal Transfer – Fee for Incomplete Procedure

1. Students who request an internal transfer and then withdraw from the procedure after receiving the academic evaluation must pay a **€50 fee**.

Article 32 – English Language Certification Exam

- 1. The cost of taking an English language certification exam in sessions organised at Politecnico di Torino by the designated certifying body is €164.90. This amount may be subject to change according to the agreement with the certifying body.

Article 33 – Italian Language Certification Exam

1. Politecnico di Torino, in collaboration with Società Dante Alighieri, organises PLIDA Italian language certification exams for its student community, with the following costs:

€114.07: full exam
 €30.50: one single test
 €54.90: two single tests
 €73.20: three single tests

These amounts may be subject to change according to the agreement with the certifying body.

Article 34 – Fee for Applicants to Master's Degree Programmes in Nanotechnologies for ICTs (MNIS path), Physics of Complex Systems (International Track), and Industrial Production and Technological Innovation Engineering

- 1. Students who are admitted to the ranking list for the Master's degree programmes in:
- Nanotechnologies for ICTs (MNIS path),
- Physics of Complex Systems (international track), and
- Industrial Production and Technological Innovation Engineering,

must pay a place reservation fee as follows:

- a. €161 for students graduating or graduated at Politecnico di Torino
- b. €61 for students graduating or graduated at other universities
 - 2. This amount will be **deducted from tuition fees** in case of enrolment. Otherwise, it **will not be re- funded**

SECTION 9 – CHECKS, VERIFICATIONS AND PENALTIES

Article 36 - Checks on self-certifications

- 1. The ISEE used to ask for a reduction in fees is a kind of self-certification. This means the person signing it is fully responsible for the truth of the information given (according to D.P.R. No. 445, 28/12/2000). If someone gives false or incorrect information, or uses false documents, they can be punished under criminal law and special rules.
- 2. The ISEE used to ask for a fee reduction can be checked after the Politecnico has given the benefit to the Student. This can happen even in later years, and even if the Student no longer studies at the University. The check is done according to the current laws.
- 3. The checks look at the family, economic, and property information of all family members listed in the ISEE for university fees. These details help calculate different economic indicators used to decide the fee.
- 4. The University does these checks by looking at data from government databases like the Revenue Agency, Land Registry, Social Security (INPS), and Chamber of Commerce. They also check data from other public offices, such as local councils for personal and residence details. The University may ask the Student for extra documents or statements to prove the information is correct.
- 5. Once the check starts, it cannot be stopped, even if the Student decides to give up the benefits.
- 6. People being checked will get messages through the University's Digital Notification Service (SEND) or other legal methods. The University will also send requests for more documents and the results of the check. Those who have not followed the rules will be told the decisions made.
- 7. Decisions can be appealed inside the University to the Head of the Unit responsible for the check, or to another person named when the check begins.

Article 37 - Results of checks

- 1. If someone is found to have given false ISEE information to get a fee reduction, they must:
 - a. Pay back the benefit they wrongly received;
 - b. Pay a fine equal to three times the amount of the wrongly received benefit (according to Art. 10, paragraph 3, D.Lgs No. 68 of 29/03/2012);
 - c. Pay an additional fine between €500 and €5,000, depending on how much money they wrongly saved (according to Art. 38, paragraph 3, DL No. 78 of 31/05/2010, converted by Law No. 122 of 30/07/2010).
- 2. The University will send the case to the Rector, who may report it to the proper authorities for any further actions or penalties according to the law and University rules.

SECTION 10 – COMMON AND FINAL RULES

Article 38 - Data handling

- Personal data given to get the fee level are handled by the Politecnico di Torino only for official purposes and to follow transparency rules, according to EU Regulation 2016/679 and Italian privacy laws. The data will be treated fairly, legally, and only for these purposes.

Article 39 - Communication and participation in administrative processes

- 1. The University will communicate with Students mainly via email to their official account.
- 2. Students shall contact the University mainly through the "Ticketing" service available on their personal page on the Didactic Portal.

Article 40 - Final rules

- 1. According to the Student Regulations (Art. 22, paragraph 1), Students can submit requests about fees. These must be sent to the Rector or their delegate, who may ask a special Commission to decide.
- 2. If necessary, for technical or operational reasons, the Director of the Students and Education Department can change procedures, deadlines, or fee amounts, especially if changes happen because of external reasons, like changes in official tax rates after these rules were made.
