

## Statement for Alta Scuola Politecnica Enrollment

I undersigned \_\_\_\_\_, ID number \_\_\_\_\_, having presented my candidature to be enrolled in the Alta Scuola Politecnica for the academic year 2025/2026 (XXII cycle), declare that I am aware that:

- The ASP programme is additional to the regular Master Degree programme and as such requires an extra effort.
- ASP activities require on-site presence. Documented health issues, concurrent scheduling with exams within the official academic calendar or other major impediments may be considered valid grounds for non-attendance of ASP activities in person, subject to approval by the ASP Board. ASP residential Schools are core activities of the ASP programme. Students must guarantee their on-site presence, under penalty of exclusion, with no exceptions linked to other academic activities. Further details will be available in the student guidelines
- While talented students may have several opportunities for additional technical and personal development within their studies, by accepting to enroll into ASP I am at the same time excluding any other conflicting opportunity. I am aware that I have to attend all the ASP courses and participate to the ASP Multidisciplinary Project.
- ASP enrolment is limited to 150 students. If I withdraw from ASP after the Opening ceremony, I understand that no other student can be admitted to replace me, causing a net loss both to ASP and to those students who did not have the opportunity to be admitted.
- ASP Benefits cannot be combined with other financial aid such as the Regional Agency for the Right to Education of Piedmont (EDISU), the Ministry of Foreign Affairs and International Cooperation (MAECI) and the TOPoliTO scholarship. Other scholarships granted by internal or external institutions may not be compatible with ASP benefits. If I have applied for these benefits I am aware that I have to inform both the ASP office and the office in charge of granting these benefits.
